E-bids are invited from eligible, reputed and experienced Civil Work contractors/firms/companies, on the basis of **Single Stage Two Envelopes bidding Procedure** for the work “**Construction of New Blocks, External Development Works**” under the PSDP funded project sponsored by HEC titled ‘Strengthening of Women University Swabi (New Campus)’ at new campus site, having adequate experience of carrying out the projects of similar nature in Government/Autonomous Organizations, registered with Pakistan Engineering Council (PEC) in relevant category and specialization code as mentioned against each, having valid Income Tax and valid KPRA registration. ### Terms & Conditions:

1. The bidders are instructed to submit their Bids through E-PAD System via <https://kp.eprocure.gov.pk>.
2. Bid solicitation documents/criteria & Instruction to bidder duly stamped and signed can be obtained from the office of the undersigned upon submission of a written application along with photocopies of valid KPRA registration, FBR Registration and PEC Registration, up to **18-05-2026**. The tender will be proceeded on KPPRA website through E-PADS System with **Rs. 8,000/-** (non-refundable) as printing/processing charges. The fee shall be paid in the form of bank draft in favour of the Treasurer, Women University Swabi or deposit in University Account No. **238739974** (UBL Main Branch Swabi – Code#0323).
3. Complete detail of Bid Security in shape of CDR i.e. Bank Name, CDR Number and Date must be submitted electronically along-with E-Bid on E-Pak Acquisition & Disposal System (E-PADS)
4. The original bid security and additional security instruments of all bidders shall be retained until signing of the contract with the best evaluated bidder or till the bid validity period, whichever is earlier as per KPPRA notification No. S.R.O (29)/Vol.1-40/2025-26: dated 29.10.2025.
5. The Earnest money/Bid security @ 2% of Engineer Estimate in favor of the Treasurer, Women University Swabi, in shape of Call Deposit/Bank Guarantee (in original) from any scheduled bank of Pakistan.

6. The bidders who quote more than 10% below up to 20% below on Engineer Estimate are required to submit 8% additional Earnest Money/Bid Security in addition to 2% bid security with the Financial Bid in shape of Call Deposit Receipt (CDR) (KPPRA Notification No.6058- 71, dated May10, 2022) otherwise his bid will be considered as non-responsive and 2% bid security will be forfeited, and the 2nd lowest bidder and so on will be considered accordingly.
7. In case of equal bid 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> etc. the lowest bidder would be decided through toss/ draw by the committee.
8. All Taxes etc. shall be deducted from the bill of the contractors/firms/companies at prescribed rates notified by the Government from time to time.
9. Bidding shall be carried out on “% above/below/At Par on BOQ cost”.
10. Incomplete/disfiguring/over-writing/by-hand/delayed bids will be considered non-responsive.
11. Those firms which are Black listed or are involved in litigation with any Government department /organizations are not allowed to participate in tendering process.
12. Tender Entry Fee @ Rs.0.03% of the total Tender Cost shall be submitted in separate envelop in the shape of original CDR at the name of the Treasurer, Women University Swabi before opening of Tender. Failing which the bidder shall be considered as non-responsive.
13. Original CDR of the Earnest money/2% Bid Security with original E-stamp paper to the effect thereof, along with original CDR of the Tender Entry fee and original CDR/Bank receipt (in case of online payment) of the printing cost, must be submitted to women University, Swabi on or before the closing date and time mentioned above. Photo Copy of CDRs OR Bank receipt will not be accepted and shall be rejected.
14. Bidders will be Technically Qualified on the basis of information provided with the Bids, as per the Criteria prescribed in the Bidding Documents. General experience, Personal Capabilities, Equipment Capabilities, Financial Soundness as well as Registration with PEC, KPRA, FBR, etc. shall be strictly calculated in the Technical Bids.
15. All the information and documents provided by the bidder must be based on facts beyond any doubt. During analysis / Scrutiny or evaluation of the proposals any misrepresentation, false statement or fake document would make a ground for rejection of the bid and will also be liable for debarment / blacklisting. Any fake document or misrepresentation detected during the currency of the contract, will render the firm to be blacklisted and would be reported to the PEC for cancellation of their registration/license.
16. The bidders are at liberty to seek any clarification or further information from the office of the Project Director, Women University Swabi, if desire on any working day during office hours.
17. The competent authority reserves the right to reject any or all the tenders by assigning the cogent reasons as per the provision contained in rule 47 of KPPRA Rules 2014.
