

## TENDER NOTICE THROUGH EPADS

In compliance with the (KPPRA) Act, 2012 and KPPRA Rules, 2014, Category-C Hospital Shabqadar, District Charsadda, invites bids through E-Pak Acquisition and Disposal System (EPAD) through single stage single Envelopes bidding procedure from the bidders registered with Income Tax, Sales Tax departments and Khyber Pakhtunkhwa Revenue Authority (where applicable) for the supply of following items for the year 2025-26. Complete quotations in all aspects should reach to the office of the Medical Superintendent Category C Hospital Shabqadar, before 14/5/2026\_ at 10:00am, which shall be opened at 11:00 am on the same day in the presence of the members of the purchase committee and bidders in the office of the Medical Superintendent Category C Hospital Shabqadar

### TERMS AND CONDITIONS:

1. Procurement would be carried out through KPPRA Rules 2014.
2. Firms/supplies/companies can obtain the list along with others terms and conditions from the office of the Medical Superintendent Category C Hospital, Shabqadar during office hours, which will be provided after written request.
3. Firms/Supplier must have a valid Income Tax, Sales Tax Certificate.
4. The Bidders are requested to give their best and final unit prices as per specifications as mentioned in other terms and condition and no negotiations in the process are allowed.
5. The bid must be valid for 30-days after its submission.
6. Bids/quotation having alternate rates shall be rejected.
7. Envelope of Bid received without specification shall be rejected.
8. Rates should be valid till 30-06-2026.
9. Bid documents must be computerized along with the stamp and signature of the authorized person of the firm and those with handwritten, open tag, non-bidding, loose paper and doubtful (misprinting, overwriting and manipulation) will not be accepted.
10. The successful bidder shall sign an agreement deed with the Medical Superintendent.
11. The successful bidder shall ensure the supply of medicines in accordance with the approved quality standards, as and when demanded by the procuring agency (Category C Hospital Shabqadar).
12. Detail Bidding documents and other requirements are available for the register bidder on KPEPADS at [www.kpk.eprocure.gov.pk](http://www.kpk.eprocure.gov.pk). The scan copy of bids to be uploaded through EPADS and original hard copy of bid security and sealed envelope and original attested stamp paper duly sealed and marked (Name of Tender) must be submitted before the closing date and time, failing to mark the tender name on envelop shall lead to disqualification.
13. Address name of contact person and Phone/Cell Numbers and email address should be clearly mentioned on the envelope.
14. All the financial bids should be submitted in separate envelopes.
15. Envelopes must be marked Confidential clearly.

16. The Competent Authority has the right to accept or reject any bid as per KPPRA Rules 47 (1).
17. In case of missing any of the above-mentioned and other prescribed terms and condition the bid should be rejected.
18. Call Deposit Receipt (CDR) must be issued from any scheduled bank operating within Tehsil Shabqadar.
