The contractors/firms must be registered (renewed/active status) with (i) Pakistan Engineering Council (PEC) in relevant category and code (ii) Khyber Pakhtunkhwa Revenue Authority (KPRA), (iii) Provincial Enlistment Committee. And FBR with valid NTN


1. Bid solicitation documents and instruction to Bidders can be obtained on EPADs before the schedule date and time.
2. The bidders should submit their E-Bids as per KPPRA Notification No .S,R.O (14)/Vol:1-24/2021-22 dated 10.05.2022.
3. Complete detail of bid security in shape of CDR i.e Bank Name, CDR number (s) and date (s) must be submitted electronically alongwith E-bid on the E-bidding system.
4. All bidders are required to be registered with Khyber Pakhtunkhwa Revenue Authority under Finance Act 2013 Act No.XXI of 2013.
5. Venue of Bid opening is in the office Divisional Forest Officer Kohistan Wildlife Division at Pattan

INSTRUCTIONS TO BIDDERS

(SINGLE STAGE SINGLE ENVOLOP E-BIDDING SYSTEM)

1. The bidders are required to quote their rates above or below on MRS-2022 (2nd bi annual)
2. The contractors quoting their bids upto a limit of 10% below on Engineer's Estimate shall submit bid security to the extent of 2% Engineer Estimate.
3. The contractors quoting their bids more than 10% below upto 20% Below on Engineering estimate shall submit alongwith their bid 8% an additional security on Engineer Estimate cost in addition to 2% bid security. If the bid is not accompanied with the required amount of additional security than it will be considered as non-responsive and 2% security shall be forfeited in favour of Government and the 2nd lowest bidder and so on will be considered accordingly.
4. Similarly, a contractor quoting bid more than 20% below shall submit with his bid an additional security on Engineers estimated cost equal to the differential amount of submitted bid and Engineers estimate alongwith detail Rate Analysis. In Case of more than 20% below bid if the bid is not accompanied by the Detail Rate Analysis and /or required amount of additional security, than the said bid shall be considered as non-responsive. All the securities submitted alongwith such non responsive

- bid shall be forfeited in favour of the Govt: and the 2nd lowest bidder so on will be considered accordingly.
5. In case detail Rate Analysis submitted with the bids is in view of the procuring entity, not convincing, the Head of the procuring entity may declare such bid as non-responsive without any further future of bids security and record reasons thereof.
 6. The procuring entity may offer the contract to next lowest bidder after due diligence in the context of financial difference between such two bids or may advertise procurement a fresh.
 7. After commencement of work by the successful bidder, the procurement entity may replace the additional security with bank guarantee of the same amount from the schedule bank if the already deposited security is not in the form of Bank Guarantee.
 8. All such effort to conspire to cartel making shall be considered as violation of Rule -44 and shall be attributed towards mis- procurement under Rule-54 of procurement Rules ibid.
 9. Electronic bid should be submitted electronically on or before the fixed date/time.
 10. Any bidder who provides incorrect information shall stand disqualified and will be debarred.
 11. Time allowed for the completion of the work as specified in the NIE shall start from the issuance of letter of acceptance (LOA).
 12. Successful bidder should sign the agreement with the department after acceptance of bid.
 13. Call deposit of schedule bank shall be accepted.
 14. If the evaluated electronic bid cost of two or more that two bidders is equal then the successful bidder will be declared through draw.
 15. Electronic bid will be displayed by online E-bidding system after 30 minutes of closing time in the presence of bidders /their representatives who choose to be present.
 16. The employer has the authority to reject a bid or all the bid assigning cogent reasons.
 17. Bid security of the 1st, 2nd and 3rd bidder for the specific work will be retained by the department till the approval of the bid.
 18. CDRs will be returned to the contractor after verification from the concerned bank and will not be returned on the tender date.
