6. Electronic Bids shall be opened on the **same day at 11:00 AM (PST)**
7. The Scan copy of the bid security must be attached with Bids on EPAD.

The Original CDR/ Bid Security must be submitted to the office of the Manager Material Management, 1st Floor, OPD Building, of Peshawar Institute of Cardiology (PIC-MTI) on or before **date & time as mentioned above**. If the original Bid Security does not reach the aforementioned office by the closing date & Time, the bid will be rejected.
9. Income Tax, stamp duty, Professional Tax and KPRA or any other Government tax will be charged as per rules. (However, PIC-MTI, Peshawar is exempted from the General Sales Tax).
