



Terms and Conditions:

1. Bid Solicitation / Bidding Documents can be downloaded from the EPADS website i.e.(www.kp.eprocure.gov.pk).
2. The eligible contractors / firms are required to submit their Bids through EPADS as well as also send their bid in hard and sealed envelopes i.e. one envelope containing "Technical Proposals" and clearly marked as "Technical Bid" accompanied, while the second envelope containing financial bids clearly marked as "Financial bid". Both Technical and Financial proposals / bids will be placed in a single sealed envelope and addressed and sent to the Office of Directorate of Eastern Zone CMG, Bacha Khan Chowk, Peshawar through registered courier service before bid submission due time.
3. The securities shall be in shape of call deposit in favor of the **Director General, CMG Peshawar.**
4. The last date and time of submission of electronic tender form is **11th May, 2026 at 12:30 PM**. The date and time of Opening of Financial Bid shall be announced after evaluation of technical bids.
5. Technical proposal must be numbered and a table of contents inserted at beginning of the proposal showing the contents of the proposal according to the numbered pages.

6. Any disfiguring / overwriting, manipulation in the tenders shall be liable to rejection.
7. The "Technical Proposals / Bids" of the firms / contractors will be evaluated based on criteria mention in the bidding Documents.
8. The scope of the work can be increase or decrease as per site requirements, non-BOQ items if any, will be paid as per MRS 2025 (1st BI Annual) / MRS based analysis if non – scheduled.
9. The "Financial Bids / Proposals" of only technically responsive qualified bidders will be opened after evaluation of Technical Bids in the presence of bidders / their representative (who may like to attend) whereas the "Financial Bids" of technically non responsive bidders shall be returned unopened to the respective contractors.
10. The bidders should submit their 2% bid security and additional bid security (if any) as per KPPRA rules and Notification No.S.R.O.(14)/Vol: 1-24/2021-22 / 6058-71dated 10th May, 2022 & Additional Security if any.
11. The call deposits i.e. bid security for the work / contract must be prepared after publishing of NIT and before the closing time of the bid.
12. In case of tie / draw amongst the responsive bidders, the bid may be decided through free toss.
