Proof of payment must be uploaded with the technical proposal, failing which the proposal shall be rejected.
2. The firms shall submit/ upload the technical and financial bids (by file uploading) through EPADS before last date and time for submission of bids (the uploaded contents shall be readable).
3. Selection will be carried out under QCBS with weightage of Technical (70%) and Financial (30%). Firms scoring less than 70% in technical evaluation shall be considered non-responsive.
4. Last date for submission of Technical and Financial Proposal through EPADS is 14-05-2026 at 1200 hours. Technical proposals will be opened on the same date at 1230 hours in the presence of the firms or their authorized representatives who chose to attend at the same address. Manual/physical submission shall not be permitted Financial proposals/ bids of only technically qualified firms will be opened on a date and venue to be communicated later after evaluation and approval of technical bids.
