

Terms & Conditions.

- The Firms/ Contractors are required Valid PEC (Pakistan Engineering Council) Code i.e EE-04 & EE-05 for Works at S. No. 03,04, and Code CE-09 for remaining works.
- The Firms/ Contractors are required valid Provincial Enlistment.
- KPPRA Active Statement.
- The CDR's (i.e 2% Earnest Money, Additional & .03%) shall be submitted to the office of undersigned on or before 18-05-2026 at 12:00 (Noon), and the tender shall be opened on the same day at 02:00 (P.M).
- As per KPPRA Notification No.SOR (29)/Vol.1-40/2025-26/699-711 dated 29/10/2025.
All bidders shall enter the detail of the bid security and where applicable, the additional security instrument in the E-PAK Acquisition and Disposal System (EPADS) at the time of bid submission. The original bid security and additional be submitted to the procuring entity well before the closing date and time of bid submission. The procuring entity shall retain the original bid security and additional security instruments of all bidders until signing of the contract with the best evaluated bidder or till the bid validity period whichever is earlier.
 - In case of failure to submit the original bid security and additional security instrument before the date and time, the procuring entity shall debar the bidder for a period of one (01) Year.
 - In the case of violation for 2nd time, blacklist him for a minimum period of three (03) years an according with the section 29 of the KPPRA act read with rule 44 of the Khyber Pakhtunkhwa Public Procurement of goods, works and As per KPPRA notification No. SRO (14)/Vol:1-24/2021-22 dated 10-05-2022 the Additional Security shall be submitted by the bidders. as under:-
- As per KPPRA Notification No. S.R.O (14).Vol:1-24/2021- 22 dated 10/05/2022 the Additional Security shall be submitted by the bidders as under.
 - The contractors quoting their bids up to a limit of 10% below Engineer Estimate shall submit bid security at the rate of 2% only of Engineer Estimate.
 - The contractors quoting their bids more than 10% below up to 20% below on Engineer's Estimate shall submit along with their bids 8% Additional Security of Engineer' Estimated cost in addition to 2% bid Security. If the bid is not accompanied with the required amount of additional security then it will be considered is non responsive and the 2% bid Security shall be forfeited in favor of Government and the second lowest bid and so on will be considered accordingly.

- iii) Similarly, a Contractor quoting bid more than 20% below shall submit with his bid an additional Security on Engineer's estimated cost equal to the differential amount of submitted bid and Engineer's estimate along with detail rate analysis. In case of more than 20% below bids, if the bid is not accompanied by the detailed rate analysis and/or required amount of additional Security, then the said bid shall be considered as non responsive.
 - iv) In case detailed rate analysis submitted with the bids is, in view of the procurement not convincing, their Head of the Procuring Entity may be clear such bid as non-responsive without any forfeiture of bid Securities and record reasons thereof.
 - v). The procuring Entities may offer the contract to next lowest bidder after due diligence the context of financial difference between such two bids are may advertised procurement of opportunity afresh.
7. For the work Mechanical / Electrical firm / contractor must be registered (and have renewal) for the year 2024-26 with electric inspector Khyber Pakhtunkhwa. The contractor shall obtain local Electrical / Mechanical workshop certificate duly verified by the SDO / Sub-Engineer in charge of this office before the opening date. This certificate and income tax invoice of the shop name must be attached with the bid documents.
8. All taxes of Provincial / Federal Government will be deducted as per rules.
9. All others terms and conditions will remain intact as per guidelines and rules framed by Provincial Government.
