3. The Bid Security and Additional Security shall be submitted as per KPPRA Notification No's: R.O(14)/vol:1-24/2021-22/6058-71 Dated 10-05-2022.
4. In case detailed rate analysis submitted with the bids is in view of the procuring Entity, not convincing, the head of the procuring Entity may declare such bid as non-responsive without any forfeiture of bid securities and will award the tender to the next lowest responsive bidder.
5. Sealed bids should reach on or before ~~12-05-2026~~ up to 12 PM and will be opened on the same date at 02-00 PM, in the presence of bidders by the tender Committee.
6. Offered bid with original CDR, (Earnest Money, Additional Security, Detailed Rate Analysis (if applicable), fresh registration of LCB, Fresh registration of KP Revenue Authority, NTN, Income Tax Certificate and Owner CNIC must be submitted in a sealed envelope to the TMO TMA Timergara.
7. Issuance of work orders, commencement of the on the above schemes shall be subject to availability of funds.
