It is pertinent to mention that the same advertisement was previously floated with the tender opening date fixed for 21-04-2026. However, in light of observations conveyed by Khyber Pakhtunkhwa Public Procurement Regulatory Authority (KP-PPRA) vide letter No. *KP-PPRA/DISCREPANCIES/21338/2025-26/649* dated 13-04-2026 and Transparency International vide letter No. *TI/2026/0414/3A* dated 14-04-2026, the said tender process has been cancelled due to non-compliance with Rule 34(1) of KP-PPRA Rules, 2014, as the required minimum response time of fifteen (15) days could not be ensured owing to staggered publication of the advertisement in newspapers. Accordingly, the procurement is hereby re-tendered in accordance with the prescribed rules.
