Terms & Conditions

1. Interested and eligible bidders/contractors should register themselves on the EPADS link <https://kp.eprocure.gov.pk/#/supplier/registration> before submitting their bids on EPADS, under the Single Stage Single-Envelope method of KPPRA Rules.
2. Bids must be submitted through EPADS on or before **15th May 2026, till 11:00 am**. The bids of participating bidders submitted through EPADS (only) will be accepted and opened publicly on **15th May 2026 at 11:30 am**. Manual bid submission is not allowed.
3. The Two (2%) original CDR of the total bid price in the name of “**WSSP Contractor Securities**” Bok Phase -V, Hayatabad must be submitted through a sealed envelope to the WSSP office, address as mentioned below. The CDR envelope must be clearly and boldly marked as “**CDR FOR HIRING OF VEHICLES/MACHINERY FOR WSSP Eid ul Azha operations Zone _____**” before the closing date and time. The call deposit must be submitted for each Zone/ Package separately.
4. Interested and eligible bidders may download BOQ and other bid documents from EPADS on payment of document fee slip of PKR: 3000/- (Non-Refundable) payable in the name of “**WSSP Contractor Securities**”, **Bank of Khyber Phase-II, Hayatabad (IBAN # PK49 KHYB 0083 0020 0915 2876)**. Immediately after the publication of the advertisement in the newspaper, up to **15th May 2026**.
5. In order to provide prompt services during Eid operations, it is suggested that contractors may apply for one package. If applying for more than one packages the contractor have competency to provide required resources smoothly for Eid operations. Otherwise, penalties will be imposed for lack / delay in services.
6. The bidding documents must be **stamped and signed** by an authorized person of the contractor/firm. All federal and provincial duties/stamp duty/taxes, including KPRA taxes, will be recoverable as per directives of the government issued from time to time. The firm must be a registered entity with KPRA. (Rule: 37A of KPPRA).
