4. All bids must be submitted electronically via EPADS (kp.eprocure.gov.pk) on or before 15<sup>th</sup> May 2026 at 02:30 pm the bids shall be opened on the same day at 03:00 pm. Bids will be opened in the presence of bidders / representatives who choose to attend at the Office of Project Director 120 FWCs (Merged Districts)/ District Population Welfare Officer, Peshawar, Directorate General, Population Welfare, phase 7, Hayatabad, Peshawar.

5. Manual submissions of the bids will not be accepted under any circumstances. While preparing the bidding documents, bidder must ensure proper pagination and sequencing in accordance with the Bid Solicitation Documents (BSDs). If deemed necessary at any Stage of the Procurement process, The Procurement Committee may require bidders to present all original/physical bid documents-complementary to the files uploaded via the EPADS portal-for verification and official record purposes.

6. The bidders are requested to give their best and final prices as no negotiations are expected. Incomplete bids or received after due date and time will not be entertained.

7. The Two percent (2%) Bid Security of the total quoted amount must be required in the form of a Call Deposit Receipt (CDR) issued by a scheduled bank. The Original Bid Security shall be submitted in sealed envelope clearly marked the tender Reference No: 120FWCs/2025-2/02 before the bid submission date and time. Failure to submit the original Bid Security within the deadline will result in rejection of the bid under KPPRA Rules and action will be taken as per KPPRA S.R.O. (29)/Vol:1-40/2025-26 dated 29 Oct 2025.

8. A Pre bid Meeting under rule-37(10) of KPPRA rules will be held on **08.05.2026** at 03:00 pm in the office of Project Director (120 FWCs)/DPWO Peshawar, Directorate General, Population Welfare Plot No.18, Sector E-8, Phase-7 near Allied Bank, Hayatabad, Peshawar.
