Terms & Conditions


1. Bidding documents can be downloaded from the official EPADS website (eprocure.gov.pk) after publication of this NIT in a daily newspaper and on the KPPRA website. The Bid Submission Documents (BSD) shall be completed properly and uploaded in scanned form through EPADS at the time of bid submission.
2. The original bid security and detailed rate analysis (where applicable), complete in all respects, shall be sent through courier and received by the Office of the Procuring Entity before the closing date and time of bids.
3. Cutting, overwriting, or tampering in the bidding documents is not permissible. Any discrepancy between the submitted documents and the hard copies shall result in disqualification, and the bid shall be declared non-responsive.
4. Bids shall be quoted as **percentage above, percentage below, or at par** with the Engineer's Estimate.
5. Bid security shall be submitted in the form of a **Call Deposit in favor of the Director General, Capital Metropolitan Government, Peshawar.**
6. Contractors/firms must possess valid **Pakistan Engineering Council (PEC)** registration with relevant category/codes.
7. Contractors quoting bids **up to 10% below** the Engineer's Estimate shall submit **2% bid security** of the Engineer's Estimated cost.

8. Contractors quoting bids **more than 10% and up to 20% below** the Engineer's Estimate shall submit, in addition to the 2% bid security, an **additional security of 8%** of the Engineer's Estimated cost. Failure to submit the required additional security shall render the bid non-responsive, and the 2% bid security shall be forfeited in favor of the Government. The next lowest bidder shall be considered accordingly.
9. Contractors quoting bids **more than 20% below** the Engineer's Estimate shall submit additional security equal to the **difference between the Engineer's Estimate and the quoted bid**, along with a **detailed rate analysis**. Non-submission of the required additional security and/or rate analysis shall render the bid non-responsive, and all securities shall be forfeited in favor of the Government. The next lowest bidder shall be considered accordingly. All additional securities shall be in the form of a Call Deposit in favor of the **Director General, Capital Metropolitan Government, Peshawar**.
10. If the detailed rate analysis is found unsatisfactory by the Procuring Entity, the bid may be declared non-responsive without forfeiture of bid security, with reasons recorded.
11. Bid securities must be prepared **after publication of the NIT and before the closing time** of bids.
12. In case of a tie among responsive bidders, the bid shall be decided through a **free toss**, which shall be final.
13. Any bidder providing false, misleading, or incomplete information or failing to submit required hard copies shall be disqualified under **Section 29(1) of the KPPRA Act read with Rule 43**, and may be recommended for **blacklisting** under **Section 29(2) read with Rule 44** of the KPPRA Rules.
14. Firms/contractors must be registered on EPADS to obtain a unique username and password for participation.
15. Valid **PEC registration and KPPRA enlistment (Active Taxpayer status)** for the current financial year must be attached with the bid.
16. The Procuring Entity reserves the right to **accept or reject any or all bids** at any stage in accordance with the KPPRA Rules.
17. The scope of work may be **increased or decreased** subject to site requirements and availability of funds.
18. Any amendment or addition made in the advertised NIT shall be implemented strictly in accordance with the **KPPRA Act & Rules**.

Note:

Work orders shall be issued to the successful bidder(s) **subject to release and availability of funds**.
