The interested and eligible bidders/contractors duly registered on EPAD link <https://kp.eprocure.gov.pk/#/supplier/registration> are eligible to apply under Single stage two-envelope method of KPPRA Rules. The E-bid must be submitted/uploaded through EPADS on or before 12/05/2026 at 12:00PM. The technical bids on EPADS (e-bidding) shall be opened on the same day at **02:00PM**.
2. Cost estimates will be provided by the bidders at their own, however Rs. 500001/- will be recorded in the EPADS just for the sake of running of EPADS.
3. The procuring entity shall evaluate the technical proposals in the manner as prescribed in the bid document and shall reject any proposal which doesn't conform to the specified requirements. The financial bids of technically accepted / responsive bids shall be opened publicly at the time, date and venue, which will be communicated to the bidder after technical evaluation through the provided email address.
4. Financial bids should accompany ORIGINAL five (5%) bid security of the total bid price in the shape of CDR in the name of "TMO TMA Wari" shall be sealed in envelope and marked as such and shall reach on below given address before the closing date and time.
5. All applicable taxes including Sales tax, Income tax, KPRA taxes, stamp duties etc. as per Government Rules enforced shall be applicable.
6. All the rates shall be quoted on (FOR) basis with free supply / delivery to the TMA office.
7. Successful bidder shall provide complete operational training to the staff.
8. Incomplete, conditional, late submitted or manual bids shall not be entertained / accepted.
9. Work Order will be subject to availability of chassis.
10. The competent authority reserves the right to accept or reject any or all tenders with cogent reason as per KPPRA Rules.
