3. The last date and time of submission of electronic tender form is 18th May, 2026 at 12:30 PM. The date and time of Opening of Financial Bid will be communicated after approval of Technical Bid.
4. Last date and time for Online Clarification is 11th May, 2026.
5. Technical proposal must be numbered and a table of contents inserted at beginning of the proposal showing the contents of the proposal according to the numbered pages.
6. Cutting / overwriting in the bid solicitation documents will not be acceptable.
7. The "Technical Proposals / Bids" of the firms / contractors will be evaluated based on criteria mention in the bidding Solicitation Documents
8. The "**Financial Bids / Proposals**" of only technically responsive qualified bidders will be opened after evaluation of Technical Bids in the presence of bidders / their representative (who may like to attend) whereas the "Financial Bids" of technically non responsive bidders shall be returned unopened to the respective contractors.
9. The securities shall be in shape of call deposit in favor of the **Assistant Director, LG & RDD Peshawar**
10.
