The bidders are required to submit bid security (in original) of an amounting to Rupees One Million before the deadline in physical form in shape of Call Deposit Receipt (CDR) / Demand Draft (DD) / Pay Order or Banker's cheque in the name of "Hospital Director MTI-MMC Mardan". An affidavit is mandatory while uploading the technical bid that bid security is also given in the financial bid.

Only Technical bids shall be opened on the same date at 11:30 AM in Conference Room of the Administration Block of the Institute.
