

NOTICE INVITING TENDERS / BIDS


Public Health Engineering (PHE) Division Kohat, Government of Khyber Pakhtunkhwa, invites bids through EPADS, for the following works, from the eligible bidders in accordance with Khyber Pakhtunkhwa Public Procurement Regulatory Authority (KP-PPRA) Rules 2014 (amended from time to time) **on Single- Stage Two Envelopes procedure**. The bidder shall have valid registration with or possessed the following valid documents (i) e-Pak Acquisition and Disposal System (EPADS) (ii) Security Exchange Commission of Pakistan (iii) Khyber Pakhtunkhwa Public Procurement Regulatory Authority (iv) Pakistan Engineering Council (Category: C-6 or above having specialized codes: CE-09, CE-10, EE-04 & EE-11(Solar) (v) Provincial Enlistment Committee, Khyber Pakhtunkhwa (vi) Khyber Pakhtunkhwa Revenue Authority (KPRA) (status shall be active) (vii) Federal Board of Revenue (FBR) (NTN & STRN statuses shall be active), (viii) Electric Contractor License (Class-E) issued by Inspectorate of Electricity, Energy & Power Department, Khyber Pakhtunkhwa, and other criteria mentioned in the BSDs.

TERMS & CONDITIONS: -

1. Bid Solicitation Documents (BSD) / Bidding or Contract Data / Bill of Quantity (BOQ) can be downloaded from the website of EPADS (kp.eprocure.gov.pk) and Khyber Pakhtunkhwa PPRA.
2. The bidder shall submit/upload the technical and financial bids [by file uploading] through EPADS before the last date and time for submission of the bid.
3. The bidder shall only submit, physically, their original bid security (ies)/additional security (ies) and tender form fees (in the shape of a call deposit receipt made in favour of the undersigned) in the office of the undersigned before the last date and time for bid submission.
4. A pre-bid meeting shall be held in the office of the undersigned on 14/05/2026 at 12:00 PM.
5. The received technical bid(s) shall be opened (downloaded from EPADS) on/after the date and time for opening of technical bids in the presence of bidders or their representatives who opt to be present.
6. The received bid(s) shall be evaluated as per the criteria mentioned in the bid solicitation documents.
7. The content of technical and financial bids, uploaded by the bidder on EPADS, shall be readable.
8. The date and time for opening of financial bid shall be announced after evaluation of technical bids.
9. Financial bids of unqualified bidder(s) shall be returned un-opened.
10. The bidders shall submit their bid security as per KP-PPRA Notification No. SRO (14)/Vol: I-24/2021- 22/6058-71 dated Peshawar, 10/05/2022.
11. Incomplete/conditional bids with unattested cutting/overwriting/disfiguring shall be considered as "non- responsive".
12. All other terms and conditions shall remain intact as per the guidelines and rules framed by the Provincial Government.
