Terms and Conditions:

All the goods must be offered with standard warranty. Firm shall give warranty in writing on an affidavit highlighted in the bidding documents, as per the "warranty offered by the concerned manufacturer and after-sales services for the equipment.

1. The offered rates should be inclusive of all applicable taxes. Tender Quoted rates will be applicable till 30 June 2026.
2. The bidder will be eligible for evaluation that are registered with the relevant tax authority for STRN, GST, and Income. Tax Dept/ FBR reputable. Registration Certificates must be attached to the bidding documents; otherwise, the bid will not be entertained.
3. All the taxes applicable will be deducted from the suppliers as per relevant rule.
4. Bid Security @ 2 % of offered rate addressed to the Senior Civil Judge (Admin), Kohat, is required to be attached with each item of the tender. Bidding documents & separate bids shall be offered for each item, without call deposit; tender shall not be entertained.
5. The successful bidder must deposit 10 % performance guarantee of the total amount under the Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules, 2014.
6. The bidder must submit an affidavit that they are not black listed with any Government / Semi-Government organisation and that the supplied item will be genuine.
7. The bidder must provide certificate with clear indications that no information has been concealed. In case distortion of facts is detected, it would be sufficient cause to disqualify the bid & will lead toward blacklisting of the prospective bidder.
8. The successful bidder will be strictly bound to supply the items according to specifications within 15 days after issuance of supply order. Failure in the supply within stipulated period or below specification shall result in cancellation of that bid & forfeiture of the Earnest Money/ Call Deposit Return (CDR) and in case of cancellation of Supply Order, new supply order will be issued to next lowest bidder.
9. Incomplete application/bid will not be entertained. The committee reserves the right to reject or discontinue the tender proceedings as well as to reject any or all the applications with the reasons. Grounds of rejection to be communicated to the bidders upon request as per rule 47(1) of KPPRA Rule, 2014.
