### TERMS AND CONDITIONS

1. Bids shall be submitted under Single Stage – Two Envelope Procedure as per Rule 46(2)(b) of KPPRA Rules 2014. Technical and Financial Proposals shall be placed in separate sealed envelopes, clearly marked as "TECHNICAL PROPOSAL" and "FINANCIAL PROPOSAL" respectively.
2. A Bid Security of 2% of the total quoted amount in the form of a Call Deposit Receipt (CDR) in the name of the District Officer Social Welfare, Dir Upper, shall be placed inside the Financial Proposal envelope.
3. An Affidavit on Stamp Paper declaring that the firm is not blacklisted by any Government Department must be submitted with the Technical Proposal.
4. Bid Forms and relevant technical specifications, along with all registration certificates and supporting documents, must be submitted as part of the Technical Proposal.
5. All pages of the bid document must be signed and stamped by the authorized representative. Bids without complete documentation or signature shall be rejected as non-responsive.
6. Bidding Documents may be obtained from this office during working hours on payment of PKR 3000/- (non-refundable) cash or Bank Slip. Original receipt must be attached with the hard copy submission.
7. Bids shall be submitted through the KPPRA ePAD online system ([www.kp.eprocure.gov.pk](http://www.kp.eprocure.gov.pk)). Bids received after the deadline shall not be entertained.
8. Bids will be opened on 01-06-2026 at 11:30 AM in the office of the District Office Social Welfare Dir Upper in the presence of bidders or their authorized representatives. While the Financial Bids will be opened after approval of Technical Bids from the Procurement Committee.
9. The Procuring Entity reserves the right to accept or reject any or all bids as per Rule 47 of KPPRA Rules 2014, without assigning any reason.
10. Consortium, joint ventures, and association bids are not eligible and shall be rejected.
11. All bidders must comply with the applicable laws and rules of the Government of Pakistan and Government of Khyber Pakhtunkhwa.
