

### Terms and Conditions:

1. Bidding Documents can be downloaded from the official EPADS website i.e. ([www.portalkp.eprocure.gov.pk](http://www.portalkp.eprocure.gov.pk)) after publishing NIT. The Bidding Documents will be filled neatly and a clear scan copy of the same will be uploaded at the time of apply through EPADS. Cutting & overwriting will not be acceptable.
2. The contractors/firms must be registered with Pakistan Engineering Council (PEC) in relevant category and must have relevant codes of Pakistan Engineering Council (PEC).
3. The securities shall be in shape of call deposit in favor of the **Assistant Director LG&RDD Shabqdar**. All bidders shall enter the details of the bid security (2% CDR) and, where applicable, the additional security (CDRs) in the EPADS system at the time of bid submission. The original bid security and additional security (CDRs), details of which have already been entered in EPADS, shall be submitted through a registered courier to the Office of AD LG&RDD Tehsil Shabqdar located at opposite FC Fort, Near PO Office Shabqdar District Charsadda before closing time of bid
4. The call deposits i.e. bid security for the work / contract must be prepared after publishing of NIT and before the closing time of the bid.
5. The rates may be offered as %age above or %age below or at-par on engineer estimate.
6. The last time and date for online clarification is up-to 05:00 pm on 20-05-2026.
7. Matters related to the retaining of Bid Securities and failure to submit Bid Security & Additional Security shall be dealt with in accordance with KPPRA Notification No. S.R.O. (29)/Vol:1-40/2025-26 dated 29<sup>th</sup> October, 2025 and matters pertaining to additional security shall be in accordance with Notification No. S.R.O. (14)/Vol: 1-24/2021-22 dated 10<sup>th</sup> May, 2022.
8. In case of rates more than 20 % below, a detailed rate analysis must be uploaded & submitted along with valid and justifiable supporting documentation.
9. The time for completion of scheme shall be as per work order. The contractor or his representative can be present at time of opening of electronic bids opening.

10. In case of tie / draw amongst the responsive bidders, the bid may be decided through free toss which shall be considered as final.
11. Any bidder who provides false, or materially inaccurate or incomplete or do not send information in hard form will be disqualified as per KPPRA Act Section 29 (1) read with KPPRA Rule (43). Furthermore, the Procuring Entity/Executing Agency will recommend and sent cases for debaring/Blacklisting and will initiate / take action in light of approved procedure / mechanism as per KPPRA Act section 29 (2) read with KPPRA Rule (44).
12. Bids will remain valid for **120 days** from the closing date of bids.
13. The firms/contractors who wants to participate in tendering process may registered themselves with the EPADS for gaining their unique username and password.
14. The PEC, FBR and KPRA registration (Active Tax Payer) must be valid for current Financial Year.
15. Any addition made in the terms & conditions in NIT advertised shall be implemented as per KPPRA Act & Rules.
