### Terms & Conditions

1. The Technical and financial bidding will be online through KP PPRA EPADS Portal. The Bidding Document are available for registered bidders on KP PPRA EPADS Portal before given Date and Time. Financial bid will be opened after approval of technical bid.
2. Bidding documents can be downloaded from the official EPADS website ([www.portalkp.eprocure.gov.pk](http://www.portalkp.eprocure.gov.pk)) after publication of the notice inviting tender (NIT).
3. **Tender Fee @0.03%** of the Engineer's estimated in the shape of CDR, If not submitted the bidder will be considered **Non-Responsive**.
4. Contractors/firms/workshops registered/pre-qualified under Office Order No. 1028-31/CEO HAZECO Dated 22/01/26 are eligible to apply. **(For Work No. 06 Only)**
5. Each Bidder is required to submit both the Sealed Bids (**Technical+ Financial**) in a single Envelope with clearly mentioned Package No. against which bidder is applying. If a Bidder is submitting only 1 technical Bid for different packages, he will be considered as Non-Responsive and will not be evaluated further.
6. The prospective bidder shall upload scanned copy of bid security in PDF form on EPADS and original will be provided with financial Bid on or before submission of bids in the office of **Assistant Director LGRDD Haripur**. An Affidavit of Bid Security must be attached with the technical bid, Non Compliance of which, the bidder will be considered as **non-responsive** and will not be evaluated further
7. The following documents are required to be submitted with the technical bid. Failure to which the bid will be considered Non-Responsive and will not be technically evaluated further:
  - i. Certificate that the Bid Security in the shape of call deposit in (Original) has been enclosed in financial bid.
  - ii. Active NTN / Income Tax certificate.
  - iii. C&W Centralized Enlistment Card of Khyber Pakhtunkhwa Peshawar for the current year.
  - iv. Copy of CNIC of the bidder.
  - v. Copy of registration and renewal of Pakistan Engineering, Council for the current year and relevant code of specialization. **(Relevant code (EE04, EE05) is Only For Work No. 06)**
  - vi. Active KPPRA Registration.
  - vii. Active "Inspectorate of Electricity, Energy & Power Department Khyber Pakhtunkhwa" License in Category "C" or "E" **(For Work No. 06 and Work No.09 only)**
8. The call deposits i.e. bid security for the work / contract must be prepared after publishing of NIT and before closing time of the electronic bid apply.
9. The original call deposit and detailed Rate analysis (if any) must be sent through courier to the **Office of the Assistant Director Senior LG&RDD Tehsil HQ, Haripur** before the bid closing time.
10. Original call deposit and Rate analysis received through Fax or by hand shall not be accepted.
11. All registered contractors/Firms are required to download the Bid Solicitation Documents (BSDs) from the official website and submit their bid strictly in accordance with the instructions provided therein.
12. Technical evaluation will be carried with criteria mentioned in bidding documents.

13. Any cutting, overwriting or manipulation in the tender form will not be accepted. Any mismatch between the scanned copies uploaded on EPADS and hard copies submitted will result in disqualification and such a bidder shall be treated as non-responsive.
14. Rates must be quoted as a percentage above, below or at Par with engineer's estimate.
15. The last date & time for seeking online clarification shall be up to 5:00 p.m. on 25th May, 2026.
16. Bid security shall be in the form of a call deposit in favor of the **Assistant Director Senior Local Government and Rural Development Department district Haripur.**
17. As per KPPRA Notification no S.R.O. (14)/Vol: 1-24/2021-22: Dated May 10, 2022: The contractors quoting their bids up to a limit of **10% below** Engineer estimate shall submit **bid security @ 2%** only of Engineer Estimate.
18. The contractors quoting their bids more than **10% below** up to **20% below** on Engineers' Estimate shall submit along with their bids **8% Additional Security** of Engineer's Estimated cost in addition to **2% bid security**. If the bid is not accompanied with the required amount of additional security, then it will be considered as non-responsive and the 2% bid security shall be forfeited in favor of Government and the second lowest bidder and so on will be considered accordingly.
19. Matters pertaining to Additional Security shall be in accordance with Notification No.S.R.O.(14)/Vol:1-24/2021-22 Dated 10<sup>th</sup> May, 2022.
20. In case detailed rate analysis submitted with the bids is, in view of the Procuring Entity, not convincing, the Head of the Procuring Entity may declare such bid as non-responsive without any forfeiture of bid securities and record reasons thereof.
21. The next lowest bidder and so on shall be considered regarding the as per **KPPRA notification No. 6058-71 Peshawar dated 10th may, 2022.**
22. Any electronic bidder who provide false, or materially inaccurate or incomplete information, or does not send information/bidding Documents in hard form will be disqualified as per **KPPRA Act Section 29 (I) read with KPPRA Rule (43)**. Furthermore, the procuring entity/Executing Agency will recommend and send cases for **debaring /Blacklisting** and will initiate/take action in light of approved procedure/mechanism as per **KPPRA Act section 29(2) read with KPPRA rule (44)**. The contractor who is already debarred by the LGE&RDD can't participate in these electronic tenders.
23. Electronic Bids will remain valid for **90 days** from the closing date of bids.
24. Tender will be received till mentioned time on the opening date of tender and the tentative comparative statement downloaded from the website will be announced at the opening time, and final result will be announced after evaluation of bids in all respect in Bid validity time.
25. Call deposit of the other bidders will be retained till approval of the tender. Call deposit 2% and additional shall be present at the time of opening with the bids.
26. All bidders must be registered with the **Khyber Pakhtunkhwa Revenue Authority (KPRA)** under finance Act 2013 (act No. XXI of 2013).
27. The **PEC and KPRA** registration (Active tax payer) must be valid for current financial year.
28. The contractor or his authorized representative maybe present at the time of opening of electronic bid.
29. Work orders will be issued as per the KPPRA notification regarding Technical Sanction and release of funds.
30. All material testing and all sort of Tests will be performed by contractor on demand of procuring entity.
31. The Procuring entity reserves the rights to reject any or all bids by communicating valid reason for rejection at any time prior to award of the contract.
32. All applicable taxes will be recoverable as per directives of the government in vogue.
