

NOTICE INVITING TENDER THROUGH EPADS

Sealed tenders based on MRS – 2025 (1st Bi – Annual) / Non MRS – items as per approved PC-I for the below mentioned works out of “Uplifting / Beautification Activities (Including Infrastructure Improvement, Monuments, Street Lights and Green Spaces) in Southern Districts of Khyber Pakhtunkhwa (Kohat, Hangu, Karak, Bannu, Laki Marwat, Tank and D.I.Khan) Provincial ADP No.950/251119 (2025-26)” are hereby invited on the basis of Single Stage Single Envelope procedure through EPADS from the Government contractors registered with PEC, enlisted with C&W Department as per Centralized Enlistment Policy of the Government of Khyber Pakhtunkhwa for the current financial year as per following schedule:

Terms & Conditions.

- Bid Solicitation Documents uploaded by the Office can be downloaded from the official EPADS website i.e. (www.eprocure.gov.pk) and KP-PPRA website (www.kppra.gov.pk) after publishing NIT. The bid documents will be filled neatly and a clear scanned copy of the same shall be uploaded at the time of apply through EPADS.
- Cutting and overwriting in the bid documents shall not be acceptable.
- The bid securities must be prepared in favor of the **Assistant Director (Senior) LG&RDD Headquarter Tank**. These securities shall be uploaded on the EPAD system at the time of bid submission and the same uploaded original bid security instrument must be delivered to the office of undersigned up to deadline for closing as mentioned above.
- The call deposits i.e. Bid Security along with (Additional Security if any), for the work/ contract must be prepared after publishing of NIT, before closing time of bid.
- The bid securities and detail rate analysis (if applicable) must be delivered through courier to the office of **Assistant Director (Sr) LG & RDD Headquarter District Tank, Bannu Road Tank** up to the closing time of bid.
- The rates may be offered as %age above or %below or At-par on engineer estimate.
- Matters related to the failure to submit Bid Security and Additional Security shall be dealt with in accordance with KPPRA Notification No. S.R.O. (29)/Vol:1-40/2025-26 dated 29th October, 2025 and matters pertaining to additional security shall be in accordance with Notification No. S.R.O. (14)/Vol: 1-24/2021-22 dated 10th May, 2022.
- The last time and date for online clarification is up-to 05:00 PM on 03-06-2026.

9. In case of more than 20 % below rates, a detailed rate analysis must be submitted along with valid and justifiable supporting documentation.
10. The contractor or his representative may be present at time of opening of electronic bids opening.
11. In case of tie/draw amongst the responsive bidders, the bid may be decided through free toss which shall be considered as final.
12. The Eligible bidder must have the relevant codes for the above mentioned works as per Pakistan Engineering Council (PEC).
13. Any Electronic Bidder who provide false, or materially inaccurate or incomplete or do not send bid securities in hard will be disqualified as per KPPRA Act Section 29(1) read with KPPRA Rule (43). Furthermore the procuring Entity/Executing Agency will recommend and sent cases for debarring/blacklisting and will initiate/ take action in light of approved procedure/ mechanism as per KPPRA Act Section 29(2) read with KPPRA Rule (44).
14. Bids will remain valid for **90 days** from the closing date of bids.
15. Prospective bidders who wish to participate in the tendering process must register themselves on EPADS in order to obtain a unique username and password.
16. All applicable taxes shall be recovered in accordance with the directives of the government.
17. The PEC and KPRA registration (Active tax payer) must be valid for current financial year.
18. The time limit of each work shall be as per the work order issued to the successful bidder and the contractor will have to start work within 15 days' time period after the issuance of work order failing which the work will be cancelled and security/ additional security (if any) will be forfeited.
19. CDRs will not be released to the contractor till the award of contract.
20. Work Order will be issued to the contractor on the availability of funds.
21. All material testing and all sorts of tests will be performed by contractor on the demand of the procuring entity.
22. The Procuring Entity may reject all bids or proposals at any time prior to the acceptance of bids or proposals in light of KPPRA Rule No.47
23. Any addition made in the terms of & conditions in NIT advertised shall be implemented as per KPPRA Act & Rules.
