

**Terms and Conditions:**


1. Bid Solicitation Documents can be downloaded from the EPADS website i.e. ([www.eprocure.gov.pk](http://www.eprocure.gov.pk)).
2. The eligible contractors / firms are required to submit their **Technical and Financial Bids** through EPADS. as well as send their bid in hard sealed envelopes i.e. one envelope containing "Technical Proposals" clearly marked as Technical Bid, and the second envelope containing financial bids marked as Financial Bid. Both envelopes will be placed in a single sealed envelope addressed to the Office of the Assistant Director Local Government & Rural Development Department, Tehsil Bahrain, Bar Swat, through registered courier service before bid submission deadline.
3. The last date and time of submission of electronic tender form is 4<sup>th</sup> June, 2026 at 12:00 PM. The date and time of Opening of Financial Bid will be communicated after approval of Technical Bid.
4. Last date and time for Online Clarification is 25<sup>th</sup> May, 2026.
5. The content of technical and financial bids, uploaded by the bidder on EPADS, shall be readable, otherwise shall be considered as non-responsive
6. The tender shall be processed according to "above / below system" based on market rate system.
7. Bidder who submitted their financial bids without a valid call deposit will be barred from

- participating in bidding process for one year.
8. The engineer estimate is framed on the current MRS 2025 (1" Bi-annual), If any item not reflected in the BOQ and required at site, shall be paid in accordance with MRS-2025/ prevailing market rates for NSI with the approval of the competent authority.
  9. Technical proposal must be numbered and a table of contents inserted at beginning of the proposal showing the contents of the proposal according to the numbered pages.
  10. Cutting / overwriting in the bid solicitation documents will not be acceptable.
  11. The "Technical Proposals / Bids" of the firms / contractors will be evaluated based on criteria mention in the bidding Solicitation Documents.
  12. The "**Financial Bids / Proposals**" of only technically responsive qualified bidders will be opened after evaluation of Technical Bids in the presence of bidders / their representative (who may like to attend) whereas the "Financial Bids" of technically non responsive bidders shall be returned unopened to the respective contractors.
  13. The securities shall be in shape of call deposit in favor of the **Assistant Director, Local Government & Rural Development Department Tehsil Bahrain, Bar Swat.**
  14. Matters related to Bid Security and Additional Security shall be dealt in accordance with KPPRA Notification No. S.R.O.(29)/Vol:1-40/2025-26 dated 29<sup>th</sup> October, 2025 and matters pertaining to additional Security shall be in accordance with Notification No.S.R.O.(14)/Vol: 1-24/2021-22 dated 10<sup>th</sup> May, 2022.
  15. In case detailed rate analysis submitted with the bids is, in view of the Procuring Entity, not convincing, the Head of the Procuring Entity may declare such bids as non-responsive without any forfeiture of bid securities and record reason thereof.
  16. Bid security of some or all the bidders will be retained by the procuring entity till approval of tender / bid validity period.
  17. The Department will not be bound to provide any machinery/ testing laboratory and the total cost on it will be borne by the contractors themselves.
  18. The call deposits i.e. bid security for the work / contract must be prepared after publishing of NIT and before the closing time of the bid.
  19. In case of Solar Project, only those contractors bid shall be entertained, whose Firms have been awarded specified code of Solar and only approved / Registered Company Solar material will be installed.
  20. Only up to Two Decimal Digits (0.00) will be considered for evaluation of the quoted Bid. If any document submitted along with bid documents found false/bogus, the registration of the Contractor /Firm shall stands cancelled/blacklisted, in addition of forfeiture of earnest money.
  21. In case of tie / draw amongst the responsive bidders, the bid may be decided through free toss.
  22. Bids will remain valid for **90 days** from the closing date of bids.
  23. The firms / contractors who want to participate in tendering process may register themselves with the EPADS for gaining their unique username and password.
  24. Any addition made in the terms and conditions in NIT advertised shall be implemented as per KPPRA Act & Rules.
  25. The procuring Entity (P.E) reserves the right to reject any or all bids under the KPPRA rules, Rule No.47
