SELECTION AND RATE CONTRACTING (CONTRACT FRAME WORK
AGREEMENT) OF (A) MEDICAL DEVICES, SUTURES, COTTON AND RELATED
ITEMS (B) MEDICINES FOR THE YEAR 2026-27

1. In compliance with the Khyber Pakhtunkhwa Public Procurement Act-2012 and Khyber Pakhtunkhwa Procurement Regulatory Authority (KPPRA) Rules–2014, Medical Teaching Institution Khyber Teaching Hospital, Peshawar invites bids through E-Pak Acquisition and Disposal (EPADS) System (<http://kp.eprocure.gov.pk/>), from
 - (i) Manufacturer/s of drugs / medicines in Pakistan, registered as such with the Drug Regulatory Authority of Pakistan (DRAP) for the quoted item/s and regulated under the Drug Act 1976, DRAP Act 2012 and the Rules framed thereunder; and
 - (ii) Manufacturer/s of medical devices in Pakistan, registered as such with the DRAP for the quoted item/s and regulated under the Drug Act 1976, DRAP Act 2012 and the Rules framed thereunder; and
 - (iii) Importer/s of drugs/medicines authorized by the goods Foreign Principal Manufacturer or producer for import/supply of the said quoted goods in Pakistan, registered as such with the DRAP for the quoted item/s falling under the Drug Act 1976 & Rules framed there under;
 - (iv) Importer/s / Indenter/s / Authorized Distributor/s of medical devices, duly authorized by the goods Foreign Principal Manufacturer or producer to import /supply the said goods in Pakistan, the quoted item/s must be registered and regulated under the DRAP Act 2012 and Rules framed thereunder;
2. The price shall be fixed and valid till 30th June 2027, the procuring agency may extend the duration for the frame work contract to another year, as per KPPRA Rules (31A) of 2014.
3. Bidding competition under this advertisement shall be conducted through **Single Stage–Two Envelopes Bidding Procedure** as per KPPRA Act 2012 and Rules frame there under. The firms shall submit the bids electronically through EPADS on or before **04th June 2026 till 10:30AM** and must ensure that searchable PDF file shall be uploaded to EPADS. Any bids submitted later than this deadline, shall not be considered and shall be rejected without any further processing.
4. The Bid Solicitation Documents of required items can be downloaded from www.kth.edu.pk and from the website of E-Pak Acquisition and Disposal (EPADS) System.
5. Mandatory bid security amounting to a flat rate of Rupees **500,000/-** against the tender as mentioned above in the shape of Call Deposit Receipt (CDR) in the name of the Hospital Director MTI-KTH must be uploaded on EPADS and submitted in original (hard copy with letter head of the company) Ordinary crossed or open Cheque, Banker Cheque, PO (Pay order) will not be acceptable as Bids security. A Tender Fee (non-refundable) @ of PKR.2,000/- in favor of Hospital Director in KTH FUND ACCOUNT PK15KHYB0121003003116602 must be uploaded on EPADS and submitted in original (hard copy).
 - i. CDR in original (hard copy) and Tender fee deposit slip in original (hard copy) in a sealed envelope which must bear clearly written words “*Selection and rate contracting (contract frame work agreement) of (a) medical devices, sutures, cotton and related items (b) medicines for the year 2026-27*” as well as full and complete identification and contact details of the bidder, shall be submitted in the Diary Section at office of the Hospital Director MTI KTH before the E-bid submission deadline i.e **04th June 2026 till 10:30AM**.
 - ii. The bid shall be considered non-responsive if the deposit slip of CDR (original hard copy) and tender fee deposit slip (original hard copy) in a sealed envelope are submitted / received later than this deadline, or delivered to some other office other than the above office, shall not be considered and shall be rejected without any further processing.
6. The pre bid will be held on **22nd May 2026 at 10:00AM** in Conference Room of the Administration Block MTI KTH.





7. The scanned bids uploaded through the EPADS must be clear and easy to read. All pages of the submitted bid shall be signed, numbered and duly stamped by the authorized person of the bidding entity as mentioned in the BSDs. The bidders are also required to submit a table of contents in the start of bid with proper page numbering on each page of the bid.
8. The bidders are required to submit the unit price (offered, TP & MRP) of quoted items on the format as prescribed in the Bidding Documents. In quotation, the Offered rate, Trade price (TP) and Maximum retail price (MRP) must be written both in words & figures.
9. The bidders shall not quote the offered prices more than the trade price of individual quoted item/s. Bidders are required and encouraged to offer the most competitive lowest price/s of their quoted item/s.
10. Bidders offering Medical devices, Sutures Cotton and Related Goods are required to submit the sample(s) of their quoted products, along with the quoted product list, both in hard and soft form, in sufficient quantities on or before 11th June 2026 up to 04:00PM. Sample/s submitted after the due date shall not be accepted and the same item/s will be considered non-responsive.
11. To facilitate data entry during bids processing, all bidders are also required to submit the quoted product list, in soft form in MS Excel format (and not in other software formats or images) on USB, duly labeled by a permanent marker with the name of bidder firm along with the words "MTI-KTH bid 2026-27". The bidders must ensure that said USB is openable and readable.
12. Bids will be opened through EPADS by Tender Opening Committee MTI KTH on **04th June 2026 at 11:00AM** in Conference Room of the Administration Block MTI KTH, Peshawar in the presence of those bidders or their representatives, who choose to attend the bids opening process.
13. The Procuring entity reserves the right to reject any or all of the bids under clause 47 of KPPRA Procurement Rules 2014.
