## **TERMS & CONDITIONS:**

1. Bid Solicitation Documents including BOQs and instructions to Bidders can be downloaded from the official website of EPADS [kp.eprocure.gov.pk](http://kp.eprocure.gov.pk) and Khyber Pakhtunkhwa PPRA ([kppra.gov.pk](http://kppra.gov.pk)) can also be obtained from the PHED Office concerned.

2. All bidders shall submit their Technical Bid and Financial Bid separately in sealed envelopes in hard form at the time of bid submission and the same bids must also be uploaded on EPADS within the stipulated date and time.

Any mismatch, discrepancy, or deficiency between the documents submitted in hard form and those uploaded on EPADS shall render the bid non-responsive.

3. Only the documents **required in the bidding documents** shall be considered for evaluation; any unnecessary documents, brochures **or promotional material** shall not be accepted, and missing required documents shall result in **rejection of the bid**.

4. The Financial Bid shall be properly filled on the prescribed BOQ/Performa issued by the procuring entity, clearly indicating the percentage above or below the Engineer's Estimate. The Financial Bid must be submitted in sealed Financial Proposal envelope in hard form and must also be uploaded on EPADS.

Any incomplete, ambiguous, overwritten, or unclear rates shall result in the bid being treated as non-responsive.

5. . In case the contractors quoting their bids more than 10% below up to 20% below on Engineers' Estimate shall submit along with their bids 8% Additional Security Of Engineer's estimated cost in addition to 2% bid security. If the bid is not accompanied with the required amount of additional security, then it will be considered as non-responsive and the 2% bid security shall be forfeited in favour of Government and the second lowest bidder and so on will be considered accordingly.

**[Similarly, a contractor quoting bid more than 20% below shall submit with his bid an additional security on Engineer's estimated cost equal to the differential amount of submitted bid and Engineers' Estimate along with detailed rate analysis]**'. In case of more than 20% below bids, if the bid is not accompanied by the detailed rate analysis and / or required amount of additional Security, then they said bid shall be considered as non-responsive.

All the securities submitted along with such non-responsive bid shall be forfeited in favour of Government and the 2nd lowest bidder and so on will be considered accordingly. **In light of Khyber Pakhtunkhwa Public Procurement Regulatory Authority Notification No.S.R.O. (14)/Vol: 1-24/2021-22/6058-71 dated 10-5-2022 which is available in the KPPRA web site.**

6. The Bid Security 2% and stamp duty according to Govt: of (Khyber Pakhtunkhwa Finance Act No. XIII of 2021) and as well as Board of Revenue & Estate Department letter No. AS (S) 3/240/2021-2/18744-874 dated 02-08-2021 has been provided in the Financial Proposal Envelopes.

7. Last date & time for submission of the bid is **08-06-2026 at 12:00 (Noon)**.

8. The Technical bids shall be opened on the same day of submission of Bids at **01:00 P.M** in presences of Contractors or their Firms' authorized representatives who opt to be present.

9. The last time and date for clarification is up to **01-06-2026 at 12:00 P.M.**

10. The bidder shall submit physically the forms of Financial Bid, Bid Security, Additional Security if any, Bid entry fee @ 0.03% enclosed in Financial Proposal.

11. The date and time for opening of financial bids shall be announced after evaluation of technical bids.

12. The following documents must be attached with the Technical bid. If the bidder fails to submit any of the following documents, the bid will be considered as non-responsive and will be rejected straight away.

9	The bidder will provide the certificate on Affidavit that the firm is not involve in any Litigation case with PHE Division Kolai Pallas Kohistan dully Attested from Oath Commissioner.
10	All Bidders Contractors are required to provide affidavit for not being served with any notice previously by this office regarding delay or stoppage of execution of Public works and nor blacklisting form PHE Department and other Departments. Failing to which, the bid of the bidder/Contractor will be rejected straight away.
11	It is mandatory for the bidders already working with this Office to attain the Performance Certificate from concerned SDO dully verified by the Executive Engineer of PHE Division

<b>13</b>	<b>Bidders will provide a Bank Statement w.e.f 01-01-2026 to 31st of May 2026 dully stamp and signed from concerned Bank.</b>

13. The Call Deposits/Additional Security of all the contractors will be retained till Approval of the tenders by the tender approving authority.

14. All other terms and conditions will be as per KPPRA rules, PEC, SBDs and other relevant laws.

15. The procuring entity with the consent of competent authority reserves the right to accept/reject or declare non-responsive any or all the participating bidder by assigning cogent reason.

16. Only the contractor, as per rule No. 37A of Khyber Pakhtunkhwa Public Procurement of goods, works and services Rules 2014 (Rules) reproduced below Necessitates that Registration of bidders with Khyber Pakhtunkhwa Revenue Authority (KPRRA) is mandatory.

***"All bidders are required to be registered with the Khyber Pakhtunkhwa Revenue Authority, established under the Khyber Pakhtunkhwa Finance Act, 2013 (Khyber Pakhtunkhwa Act No. XXI of 2013), for works, consulting and non-consulting services as listed in Schedule-II of the Act ibid".***

17. All the above NIT conditions must be followed strictly, in case of the missing of single NIT conditions the bidder shall be considered as non-responsive straight away without any notice.
