3. The bidders shall ensure that their proposals are properly tagged, sequentially page-numbered, and supported with a detailed Table of Contents to avoid any inconvenience during the evaluation of the bid proposal.
4. Bid security @2% of the quoted value shall be submitted in the shape of Call Deposit Receipt (CDR) from scheduled bank in favor of District & Sessions judge, North Waziristan at Bannu from the account of firm who submits its bid. An affidavit is mandatory that they are not blacklisted.
