2. The bidder shall submit /upload the financial bid only through EPAD before last date and time for submission of bid.
3. According to KPPRA Rules the Contractors must be registered with KP Revenue Authority with active status.
4. Last date & Time of submission of the bid is **10-06-2026 at 12.00 P.M** which will be opened on the same day at **01:00 P.M** in the presence of Government Contractors or their authorized representative who opt to be present.
5. The bid security and additional security shall be submitted as per KPPRA Notification No. S.R.O (14) /Vol: 1-24/2021-22/6058-71 dated 10-05-2022 & No. S.R.O (29)/Vol: 1-40/2025-26 dated 29-10-2025/699-711.
6. The bidder shall only submit, physically, their original bid security (s) /additional security (s) (in shape of call deposit receipt made in favor of the undersigned) in the office of the undersigned through registered post/courier before last date and time submission.
7. In case the bidder quotes more than **20 % Below** on the Engineer Estimate and the bid is not accompanied by the detail rate analysis and/or required amount of Additional Security then the Bid shall be considered as **Non-Responsive**. All the securities submitted along with such non responsive bid shall be forfeited in favor of Government and the 2<sup>nd</sup> lowest bidder and so on will be considered accordingly.
8. In Case detailed rate analysis submitted with the bids is, in view of the procurement Entity, not convincing the Head of the Procurement Entity may declared such bid as **Non-Responsive**.
9. If the evaluated electronic bid cost of two or more than two bidders are equal than the successful bid will be declared through draw.
10. The competent Authority reserves the right to reject any or all bids by assigning cogent reasons (rules 47, of KPPRA 2014)
