1. Bid Solicitation Documents can be downloaded from the EPADS website i.e. (www.eprocure.gov.pk) and KP-PPRA website. The bid documents will be filled neatly and a clear scanned copy of the same shall be uploaded at the time of apply through EPADS. Cutting and Overwriting in the bid documents shall not be acceptable.
2. The bid securities must be prepared in favor of the Assistant Director LG&RDD Torghar. A scan copy of the bid security shall be uploaded on the EPADS system at the time of bid submission and the same must be delivered to the office of Assistant Director Senior LG&RDD Torghar, District Secretariat, Judba Torghar.
3. The bid securities for the work must be prepared after publishing of NIT and before closing time of electronic bid.
4. Rates may be offered as % above or % below or At-Par on Engineer Estimate.

5. Last date and time for online clarification is 5pm on 8th June, 2026.
6. Matter pertaining to additional security shall be in accordance with notification no. S.R.O.(14)/Vol: 1-24/2021-22 dated 10/05/2022. & other latest KPPRA Notifications.
7. In case of rates quoted more than 20% below, a detailed rate analysis must be uploaded /Submitted along with valid and justifiable supporting documentation.
8. The contractor or his representative may be present at the time of opening of electronic bids.
9. In case of tie/ draw amongst the responsive bidders, the bid may be decided through free toss which shall be considered as final.
10. The eligible contractors/firms must have the relevant codes as per PEC.
11. Any bidder who provides false, or materially inaccurate or incomplete information or do not send bid securities in hard form will be disqualified as per KPPRA act section 29 (1) read with KPPRA Rule 43. Furthermore the Procuring entity / Executing agency will recommend and sent cases for debarring/Blacklisting and will initiate / take action in light of approved procedure / mechanism as per KPPRA Act section 29 (2) read with KPPRA Rule 44.
12. Bids will remain valid for 90 days from the closing date of bids.
13. Prospective bidders who wish to participate in the tendering process must register themselves on EPADS in order to obtain a unique username and password.
14. The PEC and KPRA registration (Active Tax Payer) must be valid for current financial year.
15. Any addition made in the terms and conditions in NIT advertised shall be implemented as per KPPRA Act and Rules.
16. In order to complete the schemes on time, a bidder can win only one scheme out of three. In case a bidder offers lowest rate in all schemes then only one scheme shall be awarded and the remaining schemes shall be awarded to the subsequent lowest bidders.
17. Material test shall be performed by the contractor on his own risk and cost on demand of procuring entity.
