Bid Solicitation Documents containing detailed description including evaluation criteria and other terms and conditions may be obtained from the office of the undersigned during working hours on any working day (Monday to Friday) by depositing a sum of Rs 2000/- (Nonrefundable) or may be downloaded from EPADS from the date of publication of this advertisement. The advertisement may also be downloaded from [www.kppra.gov.pk](http://www.kppra.gov.pk) website.
2. The bidders are required to submit bid security @2% (in original) of the quoted rate in the form of Call Deposit Receipt (CDR) in the name of TMO TMA Khadukhel.
3. An Affidavit is mandatory in the technical bid that bid security is placed in the financial bid. Each Envelope shall contain separately technical and financial bid clearly marked in bold and legible letters.
4. The firms shall provide their complete information along with postal as well as valid email address and phone number(s) on each of the respective envelope. Incomplete, conditional or telegraphic tenders shall not be entertained.
5. All quotations should accompany NTN, Tax Payer certificates from KPRA and FBR. Quotation received without NTN/Tax Payer certificate from KPRA and FBR will be rejected.
6. The quotations of only registered manufacturing Firms/Fabricators will be accepted.
7. The call deposit of successful firm will remain in the custody of TMA Khadukhel till supply and expiry of the specified Guarantee/Warranty period of the supplies/machinery.
8. The quotations must reach the office of the TMA Khadukhel on 09<sup>th</sup> June, 2026 up to 12:00 PM through registered courier services. Quotations received after 12:00 PM or by

- hand will not be entertained/ accepted. The bids will be opened in the presence of bidders or their authorized representatives on same day at 02:30 PM.
9. Bidders can quote the technical bid as per the bidding documents issued by this office. The Bidding Documents may be downloaded from the EPADS System.
  10. Bids will be opened under the Single Stage Two Envelope Method. The Technical and Financial Bids shall be sealed in separate envelopes, clearly marked in bold letters as Technical Bid and Financial Bid.
  11. Only technical bids will be opened on date of quotation opening in the presence of interested bidders or their authorized representatives while financial bids of technically qualified bidders will be opened on a date to be intimated later to the qualified firms.
  12. The bidder shall apply for all items, partial bid apply will be considered as non-responsive.
  13. The earnest money in the form of bank guarantee/cross cheque will not be accepted.
  14. The tender/ quotation documents which are unsigned, unstamped/ sealed, incorrect, incomplete, tampered, overwritten will be considered non responsive and will be rejected.
  15. The successful bidder has to pay all applicable Provincial/Federal Government taxes issued from time to time.
  16. The Competent Authority Reserves the right to reject any or all the bids as per provisions contained in Rule 47 of the KPPRA Rule 2014.
