1. Bid Solicitation Documents, containing detailed descriptions including evaluation criteria and other terms & conditions and Notice Inviting Tender may be downloaded from <http://kppra.gov.pk>, and [www.districtcourtsorakzai.gov.pk](http://www.districtcourtsorakzai.gov.pk) websites or can be obtained from the office of District & Sessions Judge, Orakzai.
2. The bids shall be valid till 30<sup>th</sup> June, 2026.
3. Bid Security @ 2% of the quoted value shall be submitted in the shape of Call Deposit Receipt (CDR) from scheduled bank in favor of District & Sessions Judge, Orakzai from the account of the firm who submits its bid. An affidavit is mandatory in the technical bid that bid security is placed in the financial bid.
4. Each envelop shall contain separate Technical and Financial Bid clearly marked in bold legible letters. The firms shall provide their complete information along with their postal as well as valid E-mail address and Phone Number on each envelop.
5. Bids should be complete in all respect shall reach the office of the undersigned by **12:00PM on 08.06.2026**. Only Technical Bids shall be opened on the same day at 12:30PM in the **Conference Room of District Courts Orakzai at Baber Mela, Hangu**, in presence of the members of Purchase Committee and the bidders/representatives, who choose to attend.
6. The bidder shall submit/upload the technical and financial bids (by file uploading) through EPADS on or before fixed date/time for submission of bid.
7. The content of technical and financial bids, uploaded by the bidder on **EPADS**, shall be readable.
8. Competent Authority reserves the right to reject any or all the bids as per provisions contained in Rule 47 of KP-PPRA Rules 2014.
9. All bidders must be registered with Khyber Pakhtunkhwa Revenue Authority.
10. Delivery/installation of server may be supplied/installed within 07 days of the issuance of supply order positively, failing which the supplier shall be dealt with according to law.
11. The Competent Authority may also postpone or cancel the procurement without assigning any reason.

13. Delivery shall be made to the District Courts, Orakzai at Baber Mela, Hangu.
