3. Date for opening of financial bids of the bidders will be intimated accordingly.

Contractors/bidders would have to include the BOQ showing the sales tax bifurcation details (duly filled) (received vide KPPRA Notification No.S.R.O (10) vol:1-18/2020, dated 10.02.2021) provided in the bidding documents along with call deposit & other requisite documents in the Financial Bid Envelope. In case of its non-submission, bids would be considered as Non responsive.
5. Technical Design should be based on Technical aspects of the scheme provided in the Standard Bid Documents (SBD) and rates should be quoted accordingly with above /below system.
6. Percentage of earnest money 2% of the Engineer estimate in shape of call deposit in the name of the TMO TMA Baizai , District Mohmand
