1. Tender Documents can be downloaded by interested Bidder from EPADS (<https://kp.eprocure.gov.pk>), after publication of this advertisement in the newspaper till last day for submission of Bid.
2. **Pre-Bid meeting will be held on 16/06/2026 in the office of the Director Supply Chain, HMC/ KGMC at 10:30AM**
3. The Scan copy of the bid security must be attached with Bids on EPAD. Bids without earnest money on EPADS will not be entertained.
4. Original CDR/ Bid Security on the name of "Dean, Khyber Girls Medical College (KGMC) Peshawar" must be submitted to the office of the Incharge Procurement, Khyber Girls Medical College Peshawar (KGMC) on or before **30/06/2026 at 11:00 AM (PST)**. If the original Bid Security does not reach the aforementioned office by the closing date & Time, the bid will be rejected.
5. Electronic Bids shall be opened on the same day (**30/06/2026**) at **11:30 AM (PST) at office of the Director Supply Chain, HMC/ KGMC.**
6. Any bids received late shall be rejected as per KPPRA rules (37-4).
7. The firm must have ME-03 PEC specialized code for the Sub head (a (1)). The firm can only apply for the category in which the firm is registered.
8. **No. Conditional Tender will be acceptable.** Any disfiguring/overwriting, manipulation in the tendering documents shall be liable to rejection, incomplete/conditional bids shall not be acceptable.
9. **During selection of the above heads the firms shall bring the sample (Mandatory) if required.**
10. Income Tax, stamp duty, Professional Tax and KPRA or any other Government tax will be charged as per rules.
11. Procurements will be carried out as per Act and Rules of Khyber Pakhtunkhwa Public Procurement Regulatory Authority (KP-PPRA).
12. Registration with KPRA is mandatory wherever applicable.
13. The Bid accompanied by Pay Order (PO) shall be rejected.
14. Bids received through by hand/Post/Courier; E-mail / Fax shall NOT be accepted.
15. Interested bidders who wants to participate in the tender process shall registered themselves with the EPADS for gaining their unique user's name and password.
