

**Terms and Conditions:**

1. Bid Solicitation / Bidding Documents can be downloaded from the EPADS website i.e.([www.kp.eprocure.gov.pk](http://www.kp.eprocure.gov.pk)).
2. Tender Fee @ 0.03% (Non-refundable) on Engineer Estimate shall be in shape of call deposit in favor of the Director General, CMG Peshawar. If not submitted then the firm will consider as non-responsive.
3. The eligible contractors / firms are required to submit their Technical Bids through EPADS, as well as also send their bid in envelopes i.e. one envelope containing "Tender Fee" and while the second envelope containing financial proposals / bids will be placed in a second sealed envelope and sent to the Office of Directorate of Eastern Zone CMG, Bacha Khan Chowk, Peshawar through registered courier service before bid submission due time.
4. The securities shall be in shape of call deposit in favor of the **Director General, CMG Peshawar.**
5. The last date and time of submission of electronic tender form is **8<sup>th</sup> June, 2026 at 12:30 PM.** The date and time of Opening of Financial Bid shall be announced after evaluation of technical bids.
6. Technical proposal must be numbered and a table of contents inserted at beginning of the proposal showing the contents of the proposal according to the numbered pages.
7. Any disfiguring / overwriting, manipulation in the tenders shall be liable to rejection.

8. The contractors / firms must have the relevant PEC code i.e. EE-04, EE-06, EEII (vi)
9. The "Technical Proposals / Bids" of the firms / contractors will be evaluated based on criteria mention in the bidding Documents.
10. The scope of the work can be increase or decrease as per site requirements, non-BOQ items if any, will be paid as per MRS 2025 (1<sup>st</sup> BI Annual) / MRS based analysis if non – scheduled.

The "Financial Bids / Proposals" of only technically responsive qualified bidders will be opened after evaluation of Technical Bids in the presence of bidders / their representative (who may like to attend) whereas the "Financial Bids" of technically non responsive bidders shall be returned unopened to the respective contractors.
