**NOTICE INVITING BIDS THROUGH EPADS**




**Terms and Conditions:**

1. Bid Solicitation Documents (BSD) / Bidding or Contract Data/Bill of Quantity (BOQ) can be downloaded from the official website of EPADS (kp.eprocure.gov.pk) and Khyber Pakhtunkhwa PPRA.
2. The eligible contractors / firms are required to Submit their **Technical and Financial Bid** through EPADS, **Financial proposal / bids** will be sent to the Office OF Assistant Director (Sr) LG&RDD Swabi Shamansoor District Complex through registered courier service before bid submission due time.
3. The bidder shall only submit, physically, their original bid security(ies)/additional security(ies) (in the shape of call deposit receipt made in the favor of the **Assistant Director LG&RDD Tehsil Topi**, through post/courier before the last date and time of bid submission.
4. The received/uploaded bid(s) shall be opened (downloaded from EPADS) on/after the date and time for opening of technical bids in the presence of the bidder or their representatives who opt to be present.
5. The received bid(s) shall be evaluated as per the criteria mentioned in the bid solicitation documents.
6. The contents of technical and financial bids uploaded by the bidder on EPADS, shall be readable, otherwise shall be considered as non-responsive.
7. Non-refundable tender form fee (must be placed in Technical Proposal/Bid) at the rate of 0.03% on the Engineer's estimated cost.
8. The date and time for the opening of the financial bid shall be announced after evaluation of the technical bids. The financial bids of unqualified bidder(s) shall be returned unopened.
9. Clarifications, if any, may be asked by the bidder through EPADS till 2<sup>nd</sup> June 2026.
10. **Bid Validity Period is 90 Days.**

11. The bidders shall submit their bid security (ies) as per KP-PRA Notification No. SRO (14)/Vol: I-24/2021-22/6058-71 dated Peshawar, 10/05/2022.
12. KPPRA's Notification No. S.S.R.O (29)/Vol: 1-40/2025/26/699-711 dated 29/10/2025 shall be applicable.
13. All other terms and conditions shall remain intact as per guidelines and rules framed by Provincial Government.
14. Cutting / overwriting in the bid Solicitation Documents will not be acceptable.
15. The call deposit i.e bid security for the work / contract must be prepared after publishing of NIT and before the closing time of bid.
16. In Case of Tie/ draw amongst the responsive bidders the bid may be decided through free toss.
