3. The last date and time of submission of electronic Tender form is 19" June, 2026 at 12:30 PM. The date and time of Opening of Financial Bid will be communicated after approval of Technical Bid.
4. Last date and time for online clarification is 12" June, 2026 at 05:00 PM.
5. Technical Proposal must be numbered and a table of contents Inserted at beginning of the proposal showing the contents of the proposal according to the numbered pages.
6. Cutting /overwriting in the in bid solicitation documents will not be acceptable.
7. The "Technical Bid/ Proposals" of the firms /contractors will be evaluated based on criteria mention in the bidding solicitation documents.
8. The "Financial Bid/Proposals" of only technically responsive qualified bidders will be opened after evaluation of technical bids in the presence of bidders /their representative (who like to attend) whereas the "Financial Bids" of the technically non responsive bidders shall be returned unopened to the respective contractors.
9. The securities shall be in shape of call deposit in favor of the Assistant Director (Senior) LG&RDD H.Q Bannu.
