5. Received tenders/bids will be opened at 11:00 A.M on the same date i.e. 27-06-2026 at the Principal Office, Abbottabad Public School, Main Mansehra Road, Abbottabad in the presence of bidders or their representatives who choose to attend.
6. Bidders are required to offer most competitive lowest rates of best quality items inclusive of all applicable taxes (GST, KPRA Tax, Income Tax, Professional Tax, Stamp duty & DPR etc.), as negotiations on quoted rates are not allowed under the rules. All rates will be applicable till 30-06-2027.
7. The undersigned reserves the right to reject any or all the bids as per KPPRA rules.
