

THQ HOSPITAL KABAL SWAT-INVITATION FOR BIDS (IFB) ON EPADS-KP-PPRA PORTAL

Selection of Vendor for Sehat Sahulat Program Local Purchase (SSP-LP) of Medicines, Surgical Disposables (SDs) & Non-Drug Items (NDIs) for THQ Hospital Kabal Swat during Financial Year 2026-27. The procurement shall be conducted in accordance with the Khyber Pakhtunkhwa Public Procurement Regulatory Authority (KPPRA) Act, 2012 and KPPRA Procurement Rules, 2014 through **Single Stage Two Envelope Bidding Procedure** under Rule 06(2)(b) of KPPRA Rules, 2014. The complete bidding process shall be carried out electronically through the EPADS KP-PPRA Portal.


Interested bidders must be registered with EPADS KP-PPRA system before submission of bids.

TERMS & CONDITIONS

- Bidding documents containing detailed terms & conditions, specifications and mandatory requirements are available on EPADS KP-PPRA Portal and may also be obtained from the Office of the Medical Superintendent, THQ Hospital Kabal Swat during office hours.
- Electronic bids must be submitted through EPADS on or before: **Date:09-07-2026 Time: 10:30 AM**. Electronic Technical Bids shall be opened through EPADS on: **Date:09-07-2026 Time: 11:00 AM** in the presence of bidders or their authorized representatives.
- The contract shall initially remain valid for one year, extendable subject to satisfactory performance and/or till finalization of subsequent tender.
- The bidders shall quote their maximum possible discount on Maximum Retail Price (MRP) for medicines as negotiations are not permissible under KPPRA Rules, 2014.
- Mandatory Bid Security amounting to Rs. 120,000/- (Rupees One Hundred Twenty Thousand only) in the shape of Call Deposit Receipt (CDR) shall be uploaded on the EPADS Portal and the original hard copy shall be submitted to the Administration Block, THQ Hospital Kabal. The CDR must be issued in the name of District Health Officer Swat
- The bidder/firms shall fulfill the following mandatory requirements:
 - Valid Drug Sale License under KP Drug Rules, 1982 (as amended).
 - Registration with FBR and presence on Active Taxpayer List (ATL).
 - The Firm/LP Bidder is registered with KPRA.
 - Valid registration on EPADS KP-PPRA Portal.
- Any bid shall be considered non-responsive if:
 - Bid Security is not provided.
 - Bid is submitted after prescribed deadline.
 - Bid is ambiguous, unsigned or conditional.
 - Firm/vendor is blacklisted or suspended by Health Department, Government of Khyber Pakhtunkhwa.
 - Firm/vendor is convicted or under trial in any court of law.
- A pre- bid meeting will be held on 30-06-2026 in the conference room, Admin block THQ Hospital Kabal Swat at 10:00AM.
- The successful bidder/contractor shall ensure the availability of a duly licensed pharmacy/medical store in close proximity to the main gate of THQ Hospital Kabal throughout the contract period for the timely provision of medicines and other contracted items to entitled patients.
- Bidders are required to upload all mandatory documents as mentioned in the bidding documents. Failure to comply with mandatory requirements shall render the bidder non-responsive.

Note: The District Health Officer Swat reserves the right to reject any or all the bids under clause 47 of the KPPRA Procurement Rules
