

NOTICE INVITING BIDS THROUGH EPADS

Public Health Engineering (PHE) Division-II, Peshawar, Government of Khyber Pakhtunkhwa, invites bids through EPADS, for the work/contract, administratively approved vide Additional Deputy Commissioner (F&P) Peshawar Endst. No. 4294-96 dated 22/05/2026, "Solar Based PP at VC Sheikhan Payan, Bala, Karakhel, Mashokhel, Mushtarzai, Alizai, Utmanzai, Sangu, & Rehabilitation of WSS Achini Bala, ADP No: 251268" from the eligible bidders in accordance with Khyber Pakhtunkhwa Procurement of Goods, Works and Services Rules 2014 on single stage two envelopes procedure.

Terms and Conditions:

1. Bid Solicitation Documents (BSD) which includes Bidding or Contract Data, Bill of Quantity (BOQ), & Criteria for Basic Eligibility, Technical Bid Evaluation, & Financial Bid Evaluation, can be downloaded from the website of EPADS (kp.eprocure.gov.pk) and Khyber Pakhtunkhwa PPRA.
2. The last date and time for bid submission (through EPADS) is 22nd June, 2026 at 1000 hours.
3. The bidder shall submit/upload the technical and financial bids [by file uploading] through EPADS before last date and time for submission of bid.
4. The bidder shall submit, physically, their work-wise original bid security(ies)/additional security(ies) (in the shape of call deposit receipt (CDR) made in favour of the undersigned) in the office of the undersigned through registered post/courier before last date and time for bid submission.
5. The bidder shall also submit, physically, the non-refundable production charges i.e., Rs. 2000/- Bidding Document Fee (in the form of CDR made in favour of the undersigned), in the office of the undersigned through registered post/courier before last date and time for bid submission. In case of non-submission of Bidding Document Fee, the bid shall be rejected and declared as "non-responsive".
6. The received technical bid(s) shall be opened (downloaded from EPADS) on/after 22nd June, 2026 1030 hours in the presence of bidders or their representatives who opt to be present.
7. The received bid(s) shall be evaluated as per the criteria mentioned in the bid solicitation documents.
8. The content of technical and financial bids, uploaded by the bidder on EPADS, shall be readable, otherwise shall be considered as non-responsive.
9. The date and time for opening of financial bid shall be announced after evaluation of technical bids. The financial bids of unqualified bidder(s) shall be returned un-opened.
10. The bidders shall submit their bids as per KP-PPRA Notification No. SRO (14)/Vol: I-24/2021-22/6058-71 dated Peshawar, 10/05/2022.
11. KP-PPRA's Notification No. S.R.O.(29)/Vol:1-40/2025-26/699-711 dated 29/10/2025 shall be applicable.
12. If any clarification/query is sought by any bidder, the bidder may communicate through EPADS.
13. The detail and scope of the project is mentioned in the BSD.
14. The bidder shall be registered with Khyber Pakhtunkhwa Revenue Authority (KPRA) with active status.
15. All other terms and conditions shall remain intact as per guideline and rules framed by Provincial Government.
