Technical bids will be opened at 11:30 AM on the same day, by the bids evaluation / Procurement committee in the office of Tehsil Municipal Administration LAL QILA, in the presence of bidders or their representative opted to attend. Date of financial bid opening shall be intimated accordingly.

3. The bidder shall submit/upload the technical and financial bids [by file uploading] through EPADS and also submit a physically (Hard copy) of technical bid in shape profile (Brochure) before last date and time for submission of bid to the office of TMO TMA LAL QILA.

4. The bidder shall only submit, physically, their original bid security / Additional security and bidding documents (BSD fee Rs,5000/-) fees (in the shape of call deposit receipt made in Favor of the undersigned) in the office of the undersigned through registered post/courier before last date and time for bid submission.

5. The received technical bid(s) shall be opened (downloaded from EPADS) on/after the date and time for opening of technical bids in the presence of bidders or their representatives who opt to be present.

6. The received bid(s) shall be evaluated as per the criteria mentioned in the bid solicitation documents.

7. The content of technical and financial bids, uploaded by the bidder on EPADS, shall be readable.

8. The date and time for opening of financial bid shall be announced after evaluation of technical bids.

9. Financial bids of unqualified bidder(s) shall be returned un-opened.

10. The bidders shall submit their bid security as per KP-PPRA Notification No. SRO (14)/Vol: 1-24/2021-22/6058-71 dated Peshawar, 10/05/2022.

11. Incomplete/conditional bids with unattested cutting/overwriting/disfiguring shall be considered as "non-responsive".
