- 1) Eligible Bidders shall upload their bids through EPADS portal (<https://kp.eprocure.gov.pk>) before the closing date and time. The bid must include scanned copies of the following documents in separate PDF files:

Note: It is the sole responsibility of the bidder to ensure that all the required documents are correctly uploaded and clearly legible. **Failure to submit any required document, or submission of incomplete, illegible, contrast and corrupted files, shall render the bid non-responsive.**

- 2) No hard copies of the bid documents shall be required except for the original Call Deposit Receipt (CDR) for bid security and any additional bid security, (if any). The CDRs must be issued in favor of

- Assistant Director LG&RDD Khwazakhela.** The Procuring Entity shall consider only the documents appearing on the EPADS dashboard at the time of bid opening.
- 3) Electronic Bidding shall be based on "Above / Below/at Par System" on BOQ / Engineer's Estimate, based on the MRS applicable. Only two digits after the decimal point shall be considered for evaluation purpose.
 - 4) The bidder shall submit the original sealed envelope containing the Bid Security (2% of estimated cost) in the form of Call Deposit Receipt (CDR) & additional bid security (if applicable) before the closing date and time.
 - 5) Only Call Deposit Receipts (CDR) of Scheduled Banks shall be acceptable. Bank cheques, pay orders or Bank guarantee (at Bid opening stage only) shall not be acceptable.
 - 6) The bid securities for the work must be prepared after publishing of NIT and must be reached to the office of **Assistant Director LG&RDD Khwazakhela located in Village Bhattai NC Barkalay Tehsil Khwazakhela District Swat, before closing time of bid**
 - 7) The bids will be valid for 120 days from the date of bids opening.
 - 8) In case of same rates quoted by the responsive bidders, the lowest bidder shall be decided through draw.
 - 9) Any Bidder who provides incorrect information or failed to submit the original bid security and additional security instruments before the date and time shall be liable to deal with under section 29 of the KPPRA Act read with rule 44 of 2014.

- a. *Matters related to bid Security and additional security shall be dealt in accordance with KPPRA Notification No. S.R.O (29) Vol:1-40/2025-26 dated 29th oct 2025.*
 - b. *Matters pertaining to additional security shall be in accordance with Notification No. S.R.O (14) Vol:1-24/2021-22 dated 10th May 2022.*
- 11) All the prevailing KPPRA rules / Acts and other Government Notifications will be applicable issued from time to time & will be the part of bidding documents.
 - 12) Payment to the contractors shall be subjected to the availability of funds and no claim in this regard shall be entertained
 - 13) The Employer has the authority to reject any bid or all the bids assigning cogent reasons.
 - 14) Last date for online clarification is 21st June 2026
 - 15) Any cutting/overwriting/double quoted Cost on the Cost Quoted form/Bid form/online form shall be liable to rejection of the tender and will be declared as non-responsive
 - 16) In case of Any technical or electronic fault on EPADS on the date and time of bid opening the decision of Procurement Committee shall be final
 - 17) The Procuring Entity will collect a refundable amount of 0.05% of bid cost at the time of CDRs submission to avoid ill practice of ring formation and to ensure participation of genuinely applied bidders on EPADS portal. (The collected amount will be refunded to all the bidders who participated through E-Bidding after opening of Bids on EPAD)
