




NOTICE INVITING E-TENDER (EPADS)

2. Bid Solicitation Documents (BSD) can be downloaded from EPADS. No hard copy will be issued.
3. The bid shall be stamped and signed by an authorized person of the firm before uploading on EPADS. All federal and provincial duties/stamp duty/taxes, including KPRRA Taxes, will be recoverable as per directives of the government issued from time to time. The firm must be a registered entity with KPRRA under Rule: 37A of KPPRA.
4. 2% Bid Security (CDR) from a Scheduled Bank of Pakistan, in favor of the Divisional Forest Officer, Kalam Forest Division, Madyan, must be submitted in a sealed envelope marked “Bid Security for Package ___” before the closing date and time.
5. Any disfiguring/overwriting, or manipulation in the uploaded tender/BOQ shall be liable to rejection. Other terms and conditions are available in the BSD.
6. Incomplete, conditional, late submitted, or manual bids shall not be entertained/accepted.
7. The competent authority reserves the right to accept or reject any or all tenders with cogent reason as per KPPRA Rules.
