1. 2. The quoted rates shall be valid for 3 months from the date of bid closing.
3. Rates shall be inclusive of all applicable taxes including income tax and KPRA Tax, levies and duties including stamp duty etc.
4. Rates shall also be inclusive of personals' Social Security, EOBI Contribution, Health Insurance, Group Life Insurance or any other obligations prescribed by applicable laws and regulations related to the provision of Security Guard Services.
5. The Service-Providers has also to comply with the minimum wage-rate as prescribed by the Government. In case of revision / increase in minimum wages or taxes / levies imposed by the Government, the rates may be considered for revision accordingly.
6. The Service-Provider has to make arrangement for the provision of Security on 24/7 basis.
7. The 2% bid security is a must which will be uploaded on EPADS along with the bid and the original will be delivered to the office of Chief Executive Officer WSSC Abbottabad before the closing time.
