- iii. The auction will be conducted openly on **22-6-2026 at (10:30 AM)** in the presence of all participants at site.
- iv. The highest bidder shall deposit one fourth (1/4) of his bid amount with Medical Superintendent Government Maternity Hospital, Peshawar on the same day in Pakistani rupees (PKR), otherwise his bid shall be considered as cancelled and his security amount shall stand forfeited in favor of Medical Superintendent Government Maternity Hospital, Peshawar.
