Terms & Conditions:

1. Bid proceedings would be carried out through EPADS.
2. The interested bidders are instructed to upload necessary documents on EPADS on or before **30/06/2026** by **10:00 a.m.** which will be opened on the same day at **01:30 p.m.** in presence of bidders or their representatives, whereby, "**Technical Proposal**" will be downloaded from EPADS and will be displayed accordingly.
3. Tender must be accompanied with bid security 2% in the shape of CDR only in the name of District & Sessions Judge/Chairman District Development Committee, Bannu.
4. Pre-bid meeting will be held on **29/06/2026** at 10:30 a.m. in the Conference Room of Judicial Complex, Bannu.
5. The successful bidders must deposit 10% performance guarantee of the total amount under the Khyber Pakhtunkhwa Public Procurement of Goods, Works & Services Rules 2014.
6. Incomplete, ambiguous and conditional or bellow specification bids shall not be entertained.
7. The firm/vendor should be registered with Sales Tax and Income Tax Department and FBR, having valid NTN. Valid documents of the above must be attached with bidding documents.

8. The successful bidders will be strictly bound to supply the item(s) according to specifications within stipulated period after the issuance of supply order. Failure in supply within stipulated period or below specifications shall entail in cancellation of that bid & forfeiture of the Earnest Money/Call Deposit Return (CDR) & in case of cancellation of supply order, new supply order will be issued to next lowest bidder.
9. The successful bidder shall provide the items as per Quality and Specifications mentioned in bidding documents or better than that, and will also provide product originality/genuineness certificate.
10. Quantity can be increased or decreased according to available budget. The purchases will be subject to availability of fund(s).
11. The bidders must submit an affidavit that they are not blacklisted with any Govt/Semi Govt organization.
12. The firm should include GST and all other applicable taxes while submitting rates.
13. The firm will be bound to replace the items damaged during supply. Moreover, approved tender rates will be valid till 31.12.2026 and will not be changed.
14. The competent authority reserves the right to reject all or any of the bids or may also cancel the tender at all, at any stage, subject to any reason being communicated to bidders upon proper request under Rule 47 of KPPRA Rules, 2014.
15. The sample of item(s) so supplied will be provided to the office of the undersigned before opening of tender for technical evaluation.
16. The projects are subject to availability of funds and approval from the competent authority.
