**NOTICE INVITING EPADS SYSTEM

Public Health Engineering Division Haripur Government of Khyber Pakhtunkhwa, invites bids through E-PAD system, for the following works, from the eligible firms/contractors in accordance with Khyber Pakhtunkhwa Public Procurement Regulatory Authority (KP-PPRA) Rules 2014 and E-PAD regulations-2025 on **single stage two envelopes procedure.**

TERMS & CONDITIONS: -

1. Bid Solicitation Documents (BSD) Bidding or Contract Data / Bill of Quantity (BOQ) can be downloaded from the official website of EPADS (kp.eprocure.gov.pk) and Khyber Pakhtunkhwa PPRA (kppra.gov.pk).
2. In the technical proposal envelop only mandatory valid documents i.e CNIC, PEC Registration & CE-09 code/Electrical Code valid enlistment certificate with works department, Form-H in case of companies, (FBR & KPPRA online verification certificate/slip), Affidavit of CDR on stamp paper dully attested by Oath Commissioner.
3. The bidder shall submit/upload the technical and financial bids (by file uploading) through EPADS before last date and time for submission of bid.
4. The bidders shall submit a single envelope (sealed bid), containing two separate sealed envelopes of Financial & Technical proposals.
5. The Bidders are required to send their Bids through Courier Service and the bids shall reach the Offices before the closing date and time.
6. The Call Deposits/Additional Security of all the contractors will be retained till approval of the tenders by the tender approving authority.
7. The bidder shall only submit, physically, their original bid security (ies)/additional security in favour of the undersigned through registered post/courier before last date and time for bid submission.
8. All those contractors, who have been issued letter for delay in works are not eligible in participating bidding process.
9. All contractors are directed to provide their vendor numbers in the office of undersigned.
10. The received technical bid (s) shall be opened (downloaded from EPADS) on/after the dated and time for opening of technical bids in the presence of bidders or their representatives who opt to be present.
11. The received bid (s) shall be evaluated as per the criteria mentioned in the bid solicitation documents.
12. The content of technical and financial bids, uploaded by the bidder on EPADS, shall be readable.
13. Clarifications/queries, if any, shall be asked/communicated through EPADS.
14. Participating contractors/firms are required to provide details as well as skilled labors information including their names & CNIC numbers. Moreover, only those contractors will be eligible to participate who have their workshop /warehouse (Ownership Certificate/Rent Agreement) in District Haripur, dully verified and certified by Executive Engineer/Sub Divisional Officer concerned.
- b) The contractors already working with PHE Division Haripur shall submit performance certificate dully verified by Executive Engineer/Sub Divisional Officer.
15. "Bid Security & Additional Security is required to be deposited as per KPPRA Notification bearing No. S.R.O (14)/Vol: 1-24/2021-22 dated the 10th May, 2022/6058-71"
16. In case of more than one successful bidder having same rates, the decision will be made on toss in the presence of tender committee contractors.
17. Bid entry fee@ 0.03% of tender cost should be submitted separately in the form of CDR (non-refundable).

18. Incomplete/conditional bids with unattested cutting/overwriting/disfiguring shall be considered as "non-responsive." (2)
19. All other terms and conditions shall remain intact as per guideline and rules framed by Provincial Government.
20. The procuring entity with the consent of competent authority reserves the right to accept/reject or declare nonresponsive any or all the participating bidder by assigning cogent reason.
21. In case if the Government announces public holiday on the opening date of tender the same shall be opened on next working day at the same time.
22. All bidders are required to be registered with Khyber Pakhtunkhwa Revenue Authority, established under the Khyber Pakhtunkhwa Finance Act, 2013 (Khyber Pakhtunkhwa Act No. XXI of 2013), for works, consulting and non-consulting services as listed in schedule-II of the Act bid.
23. As per KPPRA Notification No. SRO (29)/Vol:1-40/2025-26/699-711 dated 29-10-2025, failure to submit original bid security and additional security within the stipulated time shall result in debarment for one (01) year. In case of a second violation, the bidder shall be blacklisted for a minimum period of three (03) years in accordance with section 29 of KPPRA Act read with rule 44 of the KPPRA rules, 2014.
24. In case if the Government announces public holiday on the opening date of tender the same shall be opened on next working day at the same time.
