2	The bidders should submit their E-Bids as per KPPRA notification No. S.R.O (14)/Vol.I-24/2021- 22 dated 10.05.2022
3	Complete detail of Bid Security in shape of CDR i.e. Bank Name, CDR Number and Date must be submitted electronically along-with E-Bid on E-Pak Acquisition & Disposal System (E-PADs)
4	All bidders are required to be registered with the Khyber Pakhtunkhwa Revenue Authority under the Khyber Pakhtunkhwa Finance Act No. XXI of 2013
5	The original bid security and additional security instruments of all bidders shall be retained until signing of the contract with the best evaluated bidder or till the bid validity period, whichever is earlier as per KPPRA notification No. S.R.O (29)/Vol.1-40/2025-26: dated 29.10.2025.
6	Bid Solicitation Documents and Instructions to Bidders can be obtained from the office of the undersigned on any working day or downloaded from ( <a href="https://eprocure.gov.pk/">https://eprocure.gov.pk/</a> ) EPADS before the submission date and time
7	Bidders with history of blacklisting from any Government / Private Organization poor performance shall not be considered for qualification.
8	Valid NTN/GST Certificate as tax payer with FBR shall also be required.
9	Tender Entry Fee @ Rs.0.03% of the total Tender Cost shall be submitted in separate envelop in the shape of original CDR at the name of the Executive Engineer, Highway Division Dir Lower before opening of Tender. Failing which the bidder shall be considered as non-responsive
10	Photo Copy of CDR, s OR 0.03% Tender E/Fee will not be accepted and shall be strictly rejected
11	In case bid becomes tie, the award of contract shall be decided through a free toss which shall be binding & final
12	Venue of Bids Opening is in the office of the Executive Engineer C&W Highway Division Dir Lower
13	Funds release depends upon policy of Provincial Government; hence payment will be made accordingly. Bidders / Contractors agreeing with the financial constraints in respect of payment etc.
14	Financial bids must reach this office through registered courier before closing time of bid submission. in case of failure of delivery of the envelope shall rest on the bidder/company who has used the relevant courier service. The labels of the Courier Service provider may be authenticated for tracking before opening. Fake Courier delivery shall be processed as per law and would not be considered.
15	The competent authority reserve the right to reject any or all the tenders by assigning the cogent reasons as per the provision contained in rule 47 of KPPRA Rules 2014
