- 1- Bidding solicitation documents can be downloaded from the E-PAD system and KPPRA Website. However, if clarification is required, the same may also be obtained from the office of the Procuring Entity upon submission of a formal application, valid and up-to-date PEC registration, C&W Department registration card, and payment of a non-refundable printing fee of Rs. 3,000/- This facility is provided to the potential bidders of the areas of the region

where internet issues or other complication may arise during the tender submission period. The documents may be obtained during office working hours on or before 15th July, 2026.

- 2- The bidder should submit their E-bids as per KPPRA Notification No. SOR(14)/Vol:1-24/2021-22 dated 10/05/2022.
- 3- Complete Detail of Bid Security in shape of CDR i.e. Bank Name, CDR Number(s) and Date(s) must be submitted electronically along-with E-bid on the EPADS.
- 4- All Bidders are required to be registered with Khyber Pakhtunkhwa Revenue Authority under Finance Act, 2013 Act No. XXI of 2013.

TERMS AND CONDITIONS:

- 1- In case of Emergency, the contractor will be informed by C&W Department Torghar through telephone, WhatsApp or fax and he is bound to comply with the directions.
- 2- The Contractor is bound to provide following machinery in working condition on the disposal of this Department which can be verified at any stage. A certificate of each machinery ownership/contract for each Tehsil shall be provided to this Department for record which must be valid during the contract period. The machinery must be provided at locations identified by the representative of C&W Department throughout the contact period. However the contractor is bound to provide additional machinery if necessitated by the circumstances.
 - (i) Excavator = 03 Nos.
 - (ii) Tractor 4-wheel = 03 Nos.
 - (iii) Front Shawls = 01 No.
- 3- The Contractor is bound to clear the Road under jurisdiction of C&W Department and any other identified by Engineer In-charge from debris, obstruction. Landslides, snow or any other material causing vehicular traffic blockage and keep the roads open in full formation width for usual vehicular traffic after a blockage incident. Thus the responsibility of contractor is not limited to the mere removal of material but also extends to formation of a roadway and leveling dressing.
- 4- The contractor shall be liable to mobilize at the site of blockage within 24 hours of the reporting of such occurrence through this office (by phone or in writing).
- 5- In case of failure to comply with the condition "4" contractor shall be liable for a penalty of executing the work at his risk and cost without any further notice which shall be deducted from the subsequent payment.
- 6- The contractor should open an office in each Tehsil and full authorized representative to comply the directions of C&W Department in case of emergency also provide the telephone No. and address of concerned staff of machinery at emergency duties.
- 7- This Contract shall remain effective and applicable under normal circumstances throughout the year 2026-27. However, in the event of an emergency, disaster, or other extraordinary circumstances officially declared by the Provincial Disaster Management Authority (PDMA) or any competent Government authority, the provisions of this Contract shall stand suspended to the extent required for addressing the emergency. In such circumstances, the relevant Force Majeure and emergency response provisions shall be invoked, and the Employer may undertake emergency works or procurement in accordance with the applicable laws, rules, and regulations. The normal contractual and tender arrangements under this Contract shall not apply during the period of such declared emergency to the extent they are inconsistent with the emergency requirements.
- 8- Payments will be made in four equal installments on quarterly basis subject to availability of funds.
- 9- This Contract shall remain in force up to 30th June 2027.
- 10- Venue of Bids opening is office of the Executive Engineer C&W Division Torghar.
