INVITATION OF BIDS THROUGH E-PADS

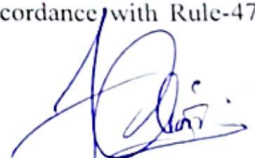
1. The Medical Superintendent, BBS (DHQ) Teaching Hospital Abbottabad, invites E-Bids through e-Pak Acquisition and Disposal System (E-PADS) from eligible bidders/firms who are reputed, financially sound, and registered with FBR (Income Tax & General Sales Tax) and KPPRA for the following works for the financial year 2026-27 under Single Stage-Single Envelope Bidding Procedure (comprising one envelope containing financial bid):

1.	Washroom BBS (DHQ) Teaching Hospital Abbottabad	2% of quoted rent
2.	Washroom Women & Children Hospital Abbottabad	2% of quoted rent

2. The date and time for submission of bids/quotations electronically is 22.07.2026 (Wednesday) at 12:30 PM. The bids shall be opened electronically on the same day in the presence of bidders or their authorized representatives, if they desire to attend.
3. The rates must be quoted on monthly rent basis separately for each work (exclusive of all applicable Government taxes) and shall remain valid up to 30.06.2027 or till finalization of the tender for the next financial year.

Terms & Conditions

4. E-Bidding documents containing detailed terms and conditions are available for registered bidders on E-PADS at <https://eprocure.gov.pk>.
5. E-Bids, prepared in accordance with the instructions contained in the bidding documents, along with bid security instrument and required documents, must be submitted through E-PADS on or before 22nd July 2026 till 12:30 PM.
6. Manual bids shall not be accepted. Original Call Deposit Receipts (CDRs) for each work must be submitted to the office of the undersigned before the bid opening date and time.
7. The bids shall be opened electronically on the same day.
8. Scanned copies of all required documents shall be uploaded through E-PADS while submitting E-Bids.
9. The successful bidder shall be bound to charge a fixed rate of Rs. 20/- per person for use of washrooms.
10. The successful bidder shall deposit six months' rent in advance.
11. **The successful bidder shall be responsible for the repair and maintenance of the washrooms of both hospitals, as identified by the hospital authority, including replacement of sewerage lines, accessories, and other related items, at his own cost. Thereafter, the contract may be extended for a further period of one year in accordance with the applicable rental policy w.e.f. 01.07.2027, subject to satisfactory performance and approval of the competent authority.**
12. The bidder must be registered with Khyber Pakhtunkhwa Revenue Authority (KPRA).
13. The competent authority reserves the right to reject single or all bids in accordance with Rule-47 of KPPRA Rules, 2014.
