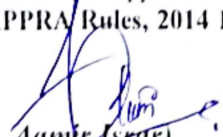
INVITATION OF BIDS THROUGH E-PADS

1. The Medical Superintendent, BBS (DHQ) Teaching Hospital Abbottabad, invites **E-Bids through e-Pak Acquisition and Disposal System (E-PADS)** from eligible firms/vendors, reputed, financially sound and registered with FBR (Income Tax & Sales Tax) for the following items/works for the financial year **2026-27** under **Single Stage – Single Envelope Bidding Method** (comprising one envelope containing financial bid).
2. The date and time for submission of bids/quotations electronically is **15.07.2026 (Wednesday) at 12:30 PM**. The bids will be opened electronically on the same day in the presence of bidders or their authorized representatives, if they so desire.
3. The quoted rates shall remain valid up to **30.06.2027** or till finalization of tender for the next financial year, whichever is earlier.

5. E-Bids, prepared in accordance with the instructions contained in the bidding documents along with bid security instrument and required documents, must be submitted through E-PADS on or before **15th Jul 2026 till 12:30 PM**.
6. Manual bids shall not be accepted. Original CDRs for each item/work must reach the office of the undersigned before the bid opening date and time.
7. The bids shall be opened electronically on the same day.
8. Scanned copies of all required documents shall be uploaded through E-PADS while submitting E-Bids.
9. For Sr. No. 11, 12 & 13, E-Bids are invited from registered Chemists and Druggists having valid retail drug license, financially sound and reputed, for patients of **BBS (DHQ) Teaching Hospital and Women & Children Hospital Abbottabad** on the basis of **maximum discount on retail price**.
10. The firm must be registered with **Khyber Pakhtunkhwa Revenue Authority (KPPRA)**, if applicable.
11. The competent authority reserves the right to reject single or all bids under **KPPRA Rules, 2014 Rule No. 47**.
