TERMS AND CONDITIONS

1. Bid Solicitation Documents containing all the terms and conditions and other relevant instructions for works can be downloaded from the department and or KPPRA websites (www.irrigation.gkp.pk) / (www.kppra.gov.pk). Electronic bidding shall be done on "Above / Below system" on BOQ / Engineer's estimate.
2. All bidder are required to have valid registration with Khyber Pakhtunkhwa Revenue Authority.
3. The bidder shall submit 2% Bid Security of the estimated cost in the shape of call deposit (in original) alongwith their bids before closing date and time in the name of Executive Engineer Tubewell Irrigation Division Peshawar, only call deposit & additional Call Deposit (CDR) of scheduled banks shall be acceptable. The bank Cheque, pay order or bank Guarantee shall not be acceptable.
4. Notifications issued by KPPRA pertaining to procurement process issued from time to time shall be applicable.
5. If the evaluated electronic bid costs of two or more bidders are equal, then the successful bidder will be declared through draw / toss.
6. Pre-bid meeting will be held on 14/7/2026 at 12:00 PM in the office of the Executive Engineer Tubewells Irrigation Division Peshawar.
7. The Bid should accompany all necessary documents Electric license original copy of issued by the Electric Inspector Khyber Pakhtunkhwa Revenue of Electric license for the current year 2026-27.

The Last date & time for Submission of the Bid along with relevant documents is 21/07/2026 up to 12:30 PM which will be opened on the same day at 01:30 PM in the office of the undersigned in presence of Contractor and their representatives who wishes to attend.

9. As per KPPRA Notification No. S.R.O(29)/Vol:1-40/2025-26, dated 29/10/2025 all bidders are required to submit the bid security and the Additional Security / Differential as already entered in EPADS, to the procuring entity before the closing date and time. In case of failure, the bidder shall be debarred for one year. Furthermore, upon a second violation, the bidder shall be blacklisted for a minimum period of three year
10. Bid security of 1st, 2nd and 3rd lowest bidders will be retained by the employer till the approval of bids by the competent Authority.
11. All Govt: Notifications/ Rules/Taxes updated from time to time shall be applicable.
12. The Bid will be received thought courier as per NIT time, date and venue. Further Bids submitted through telegraph, telex, fax or e-mail shall not be considered.
