Terms & Conditions:

- 1- The contract shall be awarded based on the Above / Below / At par system relative to the Engineer's estimate on MRS-2025 (1st BI-Annual).
- 2- Tender documents can be downloaded from the official EPADS website (eprocure.gov.pk) after the publication of the NIT in newspaper and on the KPPRA website.
- 3- The Bid Security and Additional Security must be submitted in according with KPPRA Notification No. S:R.O (14)/Vol: 1-24/2021-22/6058-71, dated 10.05.2022.
- 4- The firm / contractor must possess the following specialize PEC Codes in their PEC Registration: EE-11 (i) EE-11 (ii), EE-11 (iii), EE-11 (iv) EE-11 (vv) EE-11 (xxv).
- 5- If the detailed rate analysis submitted with the bids is in the view of the procuring Entity, un convincing, the head of the procuring Entity may declare the bid non-responsive without forfeiting the bid securities, and award the tender to the next lowest responsive bidder.
- 6- Sealed bids must arrive on or before (21.07.2026) up to 11:30 AM and shall be opened on the same date at 12:00 PM in the presence of bidders by the tender Committee.
- 7- Offered bids along with the original CDR, Earnest Money / Additional Security in the form of a CDR, Detailed Rate Analysis (if applicable), fresh registration with the LCB, KP Revenue Authority, NTN / Income Tax Certificate and the owner CNIC must be submitted in a sealed envelope to the TMO, TMA, Mardan.
- 8- The work order will be issued subject to availability of Fund.
- 9- All Federal & Provincial Duties / Taxes including Sales Tax will be recovered as per Govt. directives issued from time to time.
- 10- In the event of equal offers, the contact award shall be decided via of free toss which shall be final.
- 11- Any cutting / over writing on the Tender Form / BOQ shall render the tender liable to rejection and it will be declared non-responsive.

Any future rules and regulation or instruction issued by Provincial Government of Khyber Pakhtunkhwa / KPPRA will be applicable.

- 13- If the contractor failed to complete the work within the stipulated time frame, a 1% penalty per day will be imposed to a maximum of 10% penalty.
- 14- The minimum number of days required for clearance of IPC's is 30 days.
- 15- In the event of failure more than 3 times, the contract will be cancelled, the firm will be debarred / black listed and the security deposit will be forfeited.
- 16- The warranty period shall be 1 year. During the warranty period, the contractor is liable to rectify any damages at their own expense.
- 17- The contractor is required to submit photographs of all activities, taken before, during and after the completion of work, along with their respective coordinates.
- 18- No advance payment will be made to the contractor.
- 19- In the event of Government holiday, the tender will be opened on next working day.
- 20- All electrical works must undergo technical vetting and approval by the Assistant Engineer of the Local Council Board, and all relevant electrical items must be tested and certified by Govt. approved laboratories prior to installation.
